4) Presentation by RAND Corporation on Hospital Pricing	Brian Briscombe, RAND Corporation	1:15 pm

Brian Briscombe shared a presentation on the findings of the Round 5 study conducted by RAND Corporation. The study examines employer-sponsored commercial claims data, not Medicare and Medicaid. Employer-sponsored plans cover about half of Americans. The study tries to ascertain which hospitals are higher priced vs lower priced. The data source includes self-funded employers, APCDs, and health plans. Brian shared some of the key findings nationally and for CT.

Members and special guests asked a variety of questions. 6) Health Equity Dashboard Update	Paul Brady, OHS	2:15 pm

Paul Brady presented an update on the development of a Race, Ethnicity & Language (REL) Health Equity Dashboard, key highlights included:

- OHS and DSS received ARPA funds to develop a dashboard to identify and monitor communities that experience racial/ethnic disparities exacerbated by COVID-19. The dashboard is intended as a tool for providers and organizations to identify and meet unmet in the community. It is also intended to support the goals of PA 21-35 now CGS 19a-754d.
- Paul shared examples of existing SDoH and health equity dashboards, including from Lawrence Massachusetts, and Access Health CT.
- A health equity design group includes representatives of OHS, DPH, DMHAS, AHCT, and the Commission on Racial Equity in Public Health. The group recently determined to include the top six needs identified by hospitals as identified in the most recent OHS community health benefits report.
- Paul shared several questions for HITAC feedback. HITAC members are invited to share feedback with Paul directly.

Sumit commented that of the 1.15m in ARPA funding, 150k is for the dashboard with the remaining for implementation of new REL standards and the granular REL standards. ARPA funding needs to be committed by the end of 2024.

The floor opened for comments. Lisa Stump commented that gender equity and disparities is an area to include. Alan Kaye inquired about the funding and context for the presentation to HITAC. Adam Prizio suggested disability information be collected as a factor. He shared that the American Community Survey has a checklist of different factors of disability that could be incorporated into this data.

- The HIE Regulations Advisory Subcommittee (RAS) held its first meeting June 13th. Several concepts were discussed: patient health information, complete medical record, healthcare providers and provider waivers and the goals of the HIE.
- Tyra shared the roles of those participating in RAS meetings. Tyra stated that OHS is seeking feedback from a
  variety of provider organizations and associations, as well as interested stakeholders that will help guide the
  discussion towards developing policies, procedures and regulations. An invitation will be sent welcoming
  participation in future RAS meetings beyond that of a public commenter. Tyra stated that RAS is interested in
  developing recommendations to OHS in collaboration with the invited stakeholders and the permanent
  committee members of RAS.
- Tyra stated that a second group has been established by statute to support the development of regulations. The group must be established by OHS, by Sept 1, 2024. The group is in the development stages. Tyra gave an overview of its membership and topics.
- Tyra emphasized the importance of acknowledging the totality of what the statute says as recommendations are developed by both groups commenting that the policies and procedures cannot fall short of what is in the statute, nor can they exceed the authority of what is contained within.
- Tyra shared an overview of the tentative topics for discussion during the next RAS meeting of July 11<sup>th</sup> at 1:00. All
  meetings are open to the public.
