Application Review Workgroup

- Overall goal to evaluate our current application, as well as our overall data release process to:
 1. Create an application that is complete, straight forward, and efficient for the user and for the DRC and OHS administration.
 2. Review the entire data release process from initiation to data destruction to improve the use, delivery and value of the APCD data.
 3. Determine if changes need to be made to the process or the statute to improve the use of the data and its security.
