|           | Dr. Checko requested a motion to approve the APCD Data Release Committee May 11, 2021 meeting minutes. The motion was made by John Brady and seconded by Lisa Freeman. There was no discussion. The motion passed.   |   |                |

|           | <p>Dr. Checko introduced Ambarash Ambegaonkar to present the data request proposal submitted by Apperture LLC.</p> <ul style="list-style-type: none"> <li>Mr. Ambegaonkar provided a brief company profile for Apperture and described the team that would be assigned to analyze APCD data related to three major disease states. The project team would consist of four members with various levels of expertise.</li> </ul> |   |                |

- Mr. Ambegaonkar stated that medication adherence is an area of focus for the research study. Mr. Ambegaonkar described some of the factors associated with medication adherence referencing research published by the World Health Organization. The research team would study the consistency of these factors across the state’s most prevalent chronic diseases according to the CT-DPH website: cancer, diabetes, and asthma.
- Mr. Ambegaonkar described how the research team arrived at the data sets to request in this initial request.
- Mr. Ambegaonkar provided a detailed presentation regarding the research study design and methodology that would be used to collect and analyze the requested APCD data. Members asked a variety of questions. Dr. Checko asked Mr. Ambegaonkar to further explain the matching methodology to the group. Mr. Sajnani asked about the timeframe for which the analysis will be completed. Mr. Ambegaonkar indicated that the study should be completed within 6-9 months and the final report within 12 months. Dr. Checko informed Dr. Ambegaonkar that the APCD is only able to provide commercial data due to the agreement that the department has with Medicare. Medicaid data would need to be requested directly through Medicaid. A discussion regarding the amount of commercial data available took place. Ms. Armah also questioned how the study would identify pharmacy claims for cancer, diabetes and asthma as the data request did not include diagnoses information. Mr. Ambegaonkar responded that the study will use a known panel of prescription drugs for the three conditions based on the drugs’ national drug code (NDC) available in and requested from the APCD.
- Mr. Ambegaonkar provided an overview of the firm’s data storage and access policy. Mr. Wyvill asked for additional information regarding the firm’s intent to store data on One Drive. Mr. Ambegaonkar proposed obtaining a HIPPA compliant dedicated server. Mr. Ambegaonkar will send a revised request to the OHS team with this information.
- Ms. Armah stated that Apperture used an old version of the application to make their request. Since the new application asks for a copy of the report, Mr. Armah asked if Apperture will be able to provide a copy of their final report. Mr. Ambegaonkar stated yes, and if the analysis is to be published, Apperture will provide four weeks to OHS to approve any analysis that comes out of the study prior to publishing.

Dr. Checko requested a motion to approve the data request application from Apperture, LLC as presented. Justin Peng made the motion. Michael Giralmo seconded. Mr. Sajnani abstained. The motion passed.

Dr. Checko provided an update on the DRC Application Review Workgroup.

Highlights of the update included:

- Dr. Checko thanked the members of the DRC Application Workgroup. Dr. Checko stated that the group has met several times and it has been determined that the work of the small group is a large undertaking. They have decided to narrow the focus of their concentration to reviewing the application process of New England states only. The potential for future grant funding and issues around a shared application that would be standardized were decision-points. Dr. Checko stated that going forward, this will become a project of the full DRC. Dr. Checko stated that next steps will be inviting the New England states to a future meeting to present.
- Dr. Checko mentioned limited data sets as a potential future topic of discussion for the DRC and potential discussion with the full APCD Advisory Group.
- There was no discussion on the updates.

|           | <p>Dr. Checko and Ms. Armah provided the following general updates:</p> <ul style="list-style-type: none"> <li>• Dr. Checko announced that the DRC received its first pre-publication manuscript submitted by UConn Health Center. The DRC had approved use of APCD data to develop a suicide algorithm by UConn Health Center in a previous DRC meeting. Dr. Checko stated that the creation of a repository where papers and reports will be stored and shared will be discussed internally.</li> <li>• Ms. Armah informed the DRC that a presentation was provided to the advisory board requesting approval to collect denied claims data and updating the related data submission guide; the board approved the requests unanimously.</li> <li>• Ms. Armah updated the group regarding the federal funding opportunity becoming available to states related to the collection of claims data or improvements to the APCD analytics process. The application process has not opened yet. OHS will be applying for the grant. Dr. Checko suggested that it might be beneficial for the DRC to hear the denied claims collection presentation that was provided to the full board.</li> </ul> |                            |                |
