#### APCD Data Release Committee (APCD-DRC) Charter

- Background / Refresher
  - Reminder: OHS is establishing charters across all councils and committees
  - In accordance with the HITAC charter:
    - HITAC will ensure all committees and work groups prepare and ratify a charter...
  - APCD Advisory Group approved its charter in August
  - APCD-DRC approved its charter in October
  - APCD-DRC charter is now before this group for acceptance and then will be shared with HITAC as done with APCD-AG's

  - Accommodates submitters unable to report updated code sets



#### 2023 Regular Meeting Schedule Approval

- FOIA Compliance:
  - In accordance with §1-21(b) of the CT Freedom of Information Act, each public agency of the state shall file not later than January 31<sup>st</sup> of each year in the office of the Secretary of the State the schedule of the regular meetings of such public agency for the ensuing year and shall post such schedule on such public agency's Internet web site...
  - ...no such meetings of any such public agency shall be held <u>sooner than</u> <u>thirty days after such schedule has been filed</u>.
- Since the next APCD-AG is not until 2023, members are asked to review and approve the schedule
