 - 1) data enhancements & utilization (4 proposals)
 - 2) operational enhancements (4 proposals)

Internal Prioritization Process

- Development of 3 Rails (Tracks)
- OHS grouped proposals based on 3 factors: resources, processes, and time
 - Resources = staffing, knowledge base, technical tools
 - Processes = already in place to enable execution, coordination with other states/national efforts, stakeholder engagement (insurers/payers, employers and committees/advisory groups
 - Time horizon

Cost Estimator Tool Update

Cost Estimator Tool – Background/Refresher

- Statute (C.G.S. §19a-754a) required OHS to establish a consumer health information website.
- Fulfilling this requirement, OHS established <u>HealthscoreCT</u>
- <u>CT Healthcare Affordability Index</u> (CHAI) is a consumer affordability interactive tool - presently resides on site
- Statute (C.G.S. 19a-755a) also requires OHS to use the APCD to collect, assess, and report healthcare information relating to safety, quality, cost effectiveness, and access for all levels of healthcare. In pursuit of this, OHS launched a Cost Estimator Tool in 2019.
- Some issues identified issues have been addressed & enhancements made.

Upgraded tool includes paid amounts & out of pocket payments on 25+ commonly provided inpatient services, outpatient services/procedure, onpatient Rx drugs, durable medical equipment (DME)



*OHS hopes to brand a <u>future</u> version of the Cost Estimator (some efforts already underway)

Background

- In 2022, Office of Health Strategy (OHS) and Department of Social Services (DSS) secured approximately \$1.15 million of the American Rescue Plan Act (ARPA) funds.
- Part of the funds received was to develop a dashboard to identify and monitor communities that experience racial/ethnic disparities which were exacerbated by COVID-19.
- The dashboard will serve as a tool to support community-based healthcare providers and organizations to identify and meet unmet healthcare needs in those communities.
- Also, the dashboard is intended to support activities that lead to achieving the goals established in <u>Public Act 21-35</u> which includes eliminating health disparities and inequities by at least seventy percent across all sectors in CT.



Purpose

 The dashboard is to identify and monitor communities that experience racial/ethnic disparities exacerbated by COVID 19 and serve as a tool for healthcare providers and organizations in identifying and meeting the unmet healthcare needs.




Health Equity Design Group


