

Use Case Discussion

Use Case Examples

- Electronic Clinical Quality Measures (eCQMs)
 - Identified as high-priority use case during stakeholder engagement
 - Nine-session Design Group deployed in February 2017 to identify value propositions, functional and business requirements, and workflow diagram
 - □ **Recommendations** accepted by Health IT Advisory Council and RFP being drafted
- Immunization Reporting (submit / query)
 - Identified as high-priority use case during stakeholder engagement
 - □ Five-session Design Group currently in progress to review and align IIS system with current CDC standards and functional requirements and create high-level implementation roadmap

Use Case Discussion

Advance Directives

□ Ability to capture advance care planning (ACP) documents and share electronically

Opioid Monitoring and Support Services

Ability to access controlled prescription data both within and outside the state

Wounded Warriors

□ Ability to electronically access and share veteran health records
