Public Act 17-151: Addition to Health Care Cabinet Charge

(c) The Health Care Cabinet shall advise the Governor regarding the development of an integrated health care system for Connecticut and shall:

(5) Advise the Governor on matters relating to: (A) The design, implementation, actionable objectives and evaluation of state and federal health care policies, priorities and objectives relating to the state's efforts to improve access to health care, (B) the quality of such care and the affordability and sustainability of the state's health care system, and (C) total state-wide health care spending, including methods to collect, analyze and report health care spending data.

State Health Expenditure Accounts (SHEA)

- Calculated every five years by the Centers for Medicare and Medicaid Services (CMS) Office of the Actuary
 - Most recent data was published in June 2017 for calendar year 2014
 - Represents a consistent set of estimates that utilizes the same methodology for all states and all years included in the time series
- Based on the National Health Expenditure Accounts (NHEA) data, the official government estimates of health spending in the United States
- Used in Kaiser Family Foundation "State Health Facts" Health Costs and Budgets data

Data Methodology and Assumptions

- Includes data at the **Personal Health Care** (PHC) level:
 - Includes spending for all health care goods and services consumed
 - Excludes administration costs, government public health activity spending, and investment in certain research, structures, and equipment
- Step One Develop service-sector estimates by state of provider
- Step Two Develop payer estimates
- Step Three Develop estimates by state of residence
 - Adjust estimates to account for crossing state lines to receive health care (e.g. individual living near the border of state or specialized care is not available locally)


National Overview

- National economic activity within the health sector is the largest single share of the economy at 17.9% gross domestic product (GDP)
- Projections show that national health spending will grow at an average rate of 5.5% per year and reach \$5.7 trillion by 2026
- Per Capita Personal Health Care Spending:
 - National Average: \$8,045
 - Connecticut: \$9,859
 - Ranged from \$5,982 in Utah to \$11,064 in Alaska
- 2010-2014, National Average Growth Rate Per Year 3.1%
 - Connecticut: 2.6%
 - Ranged from 1.9% in Arizona to 4.8% per year in Alaska









2014 Connecticut Per Capita Payer Estimates

- Connecticut's Medicaid program led the nation in controlling cost trends on a per enrollee basis for the 2010-2014 period.
- Connecticut is in the middle of the pack for five-year average Medicare growth rate ranking 22nd highest, with a range of 4.1% in North Dakota to 0.2% in Louisiana.
- Connecticut has a low five-year average private insurance growth rate, ranking at 37 out of the 50 states plus DC, with a range of 7% in Kansas to -3.3% in Nevada.
