Re: Certificate of Need Determination, Report Number 04-30253-DTR Danbury Hospital Replacement/Purchase of Monitors

Dear Mr. Robilotti:

On March 11, 2004, the Office of Health Care Access ("OHCA") received your request for the replacement/purchase of monitors at the hospital.

Please be advised that OHCA has reviewed your request and makes the following findings:

- 1. Danbury Hospital ("DH") is a non-profit acute care hospital located at 24 Hospital Avenue in Danbury, CT.
- 2. DH proposes to replace patient monitors that have exceeded their useful life over a 3 year period.
- 3. DH proposes to replace/purchase 75 Telemetry Monitors, 10 Central Stations, and 11 Transport Monitors at the following locations, 10 East (Surgical), 8 West (Cardiac), 9 Tower (Medicine), 10 West (Surgical), 11 East (Oncology), and 12 West (Ortho/Neuro) during the first year for a total cost of \$871,264.
- 4. DH proposes to replace/purchase 37 Bedside Monitors, 6 Telemetry Monitors, 4 Central Stations, and 4 Transport Monitors at the following locations, 7 Tower Medical ICU, 7 Tower CCU, Emergency Department (Bedside Monitoring and Telemetry), and 7 Tower ICU during the second year for a total cost of \$820,748.
- 5. DH proposes to replace/purchase 50 Bedside Monitors, 1 Central Station, and 1 Transport Monitor at the following locations, Anesthesiology (Main OR and L&D OR),

6. The proposed replacement schedule of patient monitors will save the Hospital a significant amount of money.

Based on these findings, OHCA has determined that the proposal does meet the requirements of Section 19a-638 & 19a-639 of the Connecticut General Statutes. Therefore, it will not be necessary for you to obtain further permission from OHCA in order to proceed with the proposed replacement/purchase of patient monitors.
