Acquire a replacement MRI unit for existing New Milford practice location

Dear Dr. Ehrlich:

On June 30, 2005, the Office of Health Care Access ("OHCA") received a Certificate of Need ("CON") Determination request from Housatonic Valley Radiological Associates, P.C. ("Applicant") for the acquisition of a replacement mobile MRI unit for 131 Kent Road in New Milford, Connecticut. Additional information was submitted on September 23, 2005. Please be advised that OHCA has reviewed your request and makes the following findings:

- 1. Housatonic Valley Radiological Associates, P.C. is currently a provider of mobile MRI scanning services at the New Milford practice location.
- 2. The Applicant proposes to replace the 1.0 Tesla mobile MRI unit presently in operation at the New Milford location with a 1.5 Tesla mobile MRI unit. Related project costs are as follows:

CT scanner \$345,000
Sales tax \$20,700
Delivery & Installation Included
Total project cost \$365,700

- 3. No new construction or renovation is required for the project.
- 4. No facility fee will be charged.
- 5. A binding purchase agreement was entered into between the Applicant and Barrington Medical Imaging, LLC prior to July 1, 2005, wherein the Applicant agrees to buy a mobile GE Signa Horizon 1.5 MRI unit at an equipment purchase price of \$345,000. The contract required \$5,000 down payment at the time of signing. The \$5,000 down payment was paid by the Applicant on June 28, 2005. A cancelled check has been provided to OHCA.

Based on the above findings, OHCA has determined that Housatonic Valley Radiological Associates, P.C. is not required to file a Certificate of Need request for the purchase of a replacement mobile MRI unit for 131 Kent Road in New Milford, Connecticut as the Applicant made certain binding commitments related to this MRI unit acquisition prior to the implementation of Public Act 05-93. The Applicant has provided to OHCA satisfactory evidence that it purchased the MRI equipment for under \$400,000 prior to July 1, 2005 and further OHCA authorization is not required.

The Applicant is required to provide to OHCA, by December 31, 2005, evidence that the Applicant has, by that date, taken full possession of the replacement mobile MRI unit. Any request to provide such evidence beyond that date, must be accompanied by a full and satisfactory explanation as to the specific and previously unforeseen barriers which have or do exist, which prevent the Applicant taking full possession by December 31, 2005.
