Norwalk Hospital

Various Repair and Maintenance Projects Related to the Norwalk Hospital Campus

Building

Dear Ms. Santoro:

On July 26, 2005, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") Determination request concerning the proposal of Norwalk Hospital ("Hospital") to perform various repair and maintenance projects related to the Hospital campus building, each of which is under \$1 Million and for a total capital expenditure of \$5,200,000.

OHCA has reviewed the information contained in the request and makes the following findings:

- 1. The Hospital is proposing to implement several maintenance repair projects (17 in total) to address maintenance issues associated with the hospital campus building located at 34 Maple Street, Norwalk, Connecticut.
- 2. Over the years, limited routine maintenance and/or repairs have been performed to the hospital building, however, previously deferred routine maintenance projects are now in need of attention.

- 3. The Hospital engaged a facility management professional services firm to conduct a maintenance assessment of the building infrastructure (structural, mechanical, plumbing, cooling/ventilation, heating, electrical and interior/exterior shell) to identify routine maintenance needs.
- 4. The result of the maintenance assessment identified the following areas of maintenance which require attention:

16.	Balance water	250,000
17.	Ventilation and duct repairs and cleaning	170,000

- 5. The cost per maintenance project is under \$1 million and the combined proposed total capital expenditure for the seventeen projects is \$5,200,000. Each project is unrelated and independent of the other projects.
- 6. The Hospital will fund each of the proposed projects through Hospital equity, specifically through operating funds.

Based on the above findings, OHCA has determined that Certificate of Need approval is not required for Norwalk Hospital to perform various repairs and maintenance for the Hospital building as the cost of each of the proposed projects is under the \$1,000,000 threshold, pursuant to Section 19a-639 of the Connecticut General Statutes.
