Transfer of Ownership Pursuant to Section 19a-493b(c) of the Connecticut General

Statutes

Dear Attorney Gerner:

The Office of Health Care Access ("OHCA") is in receipt of your request for a CON Determination Report for the transfer in ownership of Connecticut Eye Surgery Center South, LLC, an Outpatient Ophthalmic Surgical Center located in Milford, Connecticut.

Upon review of the information contained in the request, OHCA finds the following:

- 1. Connecticut Eye Surgery Center South, LLC ("CESCS") is a single specialty outpatient ophthalmic surgical center ("Center") located at 60 Wellington Road, Milford, Connecticut.
- 2. CESCS is presently wholly owned (100%) by the following physicians:

3. CESCS would like to transfer part of it's ownership to include the following physicians as part owners:

- 4. The transfer of ownership is being proposed as follows:
  - The existing thirteen physicians will sell 28% ownership;
  - The additional 8 physicians will purchase the 28% at a total cost of \$980,000; and
  - After the transfer of ownership, 100% of the Center will be owned by the 21 physicians.
- 5. As a result of this transfer in ownership, CESCS will not add any new services.
- 6. CESCS's current target population consists of individuals who need eye surgery and who live in the existing service area which includes the towns of Shelton, Milford and the municipalities in Southern New Haven and Northeastern Fairfield counties. There will be no change in the target population.
- 7. The total capital expenditure associated with the proposed change in ownership is \$980,000.
- 8. The total capital expenditure of \$980,000 will be funded through the 8 new physicians.

Based on these findings, OHCA has determined that the proposed transfer in ownership is consistent with requirements of Section 19a-493b(c) which states that a CON is not required if after the transfer of ownership no less than 60% interest of the outpatient surgical facility is owned by physicians. Therefore, a Certificate of Need is not required for the proposed transfer of ownership.
