Dear Ms. Dreger:

The Office of Health Care Access ("OHCA") is in receipt of your request for exemption from the Certificate of Need ("CON") process, pursuant to Section 19a-639b of the Connecticut General Statutes ("C.G.S."), to establish a psychiatric outpatient treatment program for adults and children at 553 Portland-Cobalt Road in Portland.

Upon review of the information contained in the request, OHCA finds the following:

- 1. Affirmation Counseling Center, LLC ("ACC") is a non-profit facility that provides ambulatory psychiatric outpatient services as a private practice employing individual clinicians to provide counseling services to children, adolescents, adults, couples and families at 553 Portland-Cobalt Road in Portland, Connecticut.
- 2. ACC is proposing to establish a psychiatric outpatient treatment program for adults and children at 553 Portland-Cobalt Road in Portland.
- 3. The Department of Mental Health and Addiction Services ("DMHAS"), in a letter dated June 26, 2006, from Deputy Commissioner Peter B. Rockholz, M.S.S.W., recommends an exemption under CGS Section 19a-639b for Affirmation Counseling Center, LLC to provide outpatient psychiatric services for adults.

- 4. DMHAS states that ACC will serve the Portland, East Hampton, Cromwell, Middletown and Middlefield area. The facility anticipates serving approximately 100 to 120 clients annually.
- 5. The Department of Children and Families ("DCF"), in a letter dated May 2, 2006, from Commissioner Darlene Dunbar, MSW, supports the proposal and the waiver of the CON requirements, pursuant to Section 19a-639b, C.G.S.
- 6. DCF states that this program provides evaluations, diagnoses, and ambulatory treatment of individuals who have mental, emotional or behavioral problems, disturbances dysfunction or disorders. The population currently served is predominately Caucasian middle class adults and children. ACC would like to include adults and children of varied cultural, ethnic, and economic backgrounds that may be on state Husky insurance, uninsured, or who need outpatient psychiatric services but are currently underserved.
- 7. The total capital expenditure associated with the proposal is \$0.

Based on the above findings, OHCA has determined that Affirmation Counseling Center, LLC's request to establish a psychiatric outpatient treatment program for adults and children at 553 Portland-Cobalt Road in Portland meets the exemption requirements of Section 19a-636b of the Connecticut General Statutes and, therefore, is exempt from OHCA's CON process. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
