Dear Mr. Malone:

On April 7, 2006, the Office of Health Care Access ("OHCA") received your request for the relocation of the Substance Abuse Outpatient Treatment Program from 313 Main Street, Norwich, Connecticut, to 321 Main Street, Norwich, Connecticut.

Please be advised that OHCA has reviewed your request and makes the following findings:

- 1. Southeastern Council on Alcoholism and Drug Dependence, Inc. ("SCADD") is a non-profit facility providing adult outpatient psychiatric and substance abuse treatment at various locations in Connecticut.
- 2. SCADD d/b/a Altruism House for Men is proposing to relocate its Substance Abuse Outpatient Treatment Program from 313 Main Street, Norwich, Connecticut, to 321 Main Street, Norwich, Connecticut.
- 3. The primary service area and target population will not change as a result of the relocation of the program.
- 4. No additional programs are proposed and no programs will be terminated.
- 5. The total capital expenditure associated with this relocation is \$40,000.
