CON Exemption Pursuant to Section 19a-639b, C.G.S.
Establish Psychiatric Outpatient Treatment Program for Adults in New Haven

Dear Mr. Gonzalez:

The Office of Health Care Access ("OHCA") is in receipt of your request for exemption from the Certificate of Need ("CON") process, pursuant to Section 19a-639b of the Connecticut General Statutes ("C.G.S."), to establish a psychiatric outpatient treatment program for adults at 116 Sherman Avenue in New Haven.

Upon review of the information contained in the request, OHCA finds the following:

- 1. Hispanos Unidos, Inc. is a non-profit facility that currently provides psychiatric evaluation, medication, and individual and group therapy through consulting psychiatrists and psychotherapists to adults in the Latino community with HIV/AIDs at 1116 Sherman Avenue in New Haven.
- 2. Hispanos Unidos, Inc. is proposing to establish a psychiatric outpatient treatment program for adults at 116 Sherman Avenue in New Haven.
- 3. The Department of Mental Health and Addiction Services ("DMHAS"), in a letter dated June 22, 2006, from Deputy Commissioner Peter B. Rockholz, M.S.S.W., recommends an exemption under CGS Section 19a-639b for Hispanos Unidos, Inc. to provide outpatient and psychiatric services for adults.

- 4. DMHAS states that Hispanos Unidos, Inc. anticipates serving approximately 300 clients annually.
- 5. The total capital expenditure associated with the proposal is \$3,000.00.

Based on the above findings, OHCA has determined that Hispanos Unidos, Inc.'s request to establish a psychiatric outpatient treatment program for adults at 116 Sherman Avenue in New Haven meets the exemption requirements of Section 19a-636b of the Connecticut General Statutes and, therefore, is exempt from OHCA's CON process. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
