RE: A Certificate of Need Determination under Report Number 06-30861-DTR The acquisition of an MRI unit for New Milford office location of HVRA

Dear Attorney Groves:

On October 5, 2005, under a previous Certificate of Need Determination identified as Report Number 05-30542-DTR, the Office of Health Care Access ("OHCA") issued a Certificate of Need Determination to Housatonic Valley Radiological Associates, P.C. ("HVRA" or "Applicant") that stated that HVRA was not required to file a Certificate of Need request for the purchase of a replacement mobile MRI unit for 131 Kent Road in New Milford, Connecticut as the Applicant made certain binding commitments related to this MRI unit acquisition prior to the implementation of Public Act 05-93. Such CON Determination was issued by OHCA specific to the enactment of Public Act 05-93.

Pursuant to Section 3 of Public Act No. 06-28, AN ACT CONCERNING CERTIFICATE OF NEED CAPITAL EXPENDITURE THRESHOLDS, "Each ... provider that proposes to purchase, lease or accept donation of a CT scanner, PET scanner, PET/CT scanner, MRI scanner, cineangiography equipment or a linear accelerator shall be exempt from certificate of need review pursuant to sections 19a-638, as amended by this act, and 19a-639, as amended by this act, if such ... provider (1) provides to the office satisfactory evidence that it purchased or leased such equipment for under four hundred thousand dollars on or before July 1, 2005, <u>and such</u> equipment was in operation on or before July 1, 2006, or (2) obtained, on or before July 1, 2005, from the office, a certificate of need or a determination that a certificate of need was not required for the purchase, lease or donation acceptance of such equipment. This law was approved on May 8, 2006 and effective upon passage.

- 1. The mobile MRI unit was previously located in the State of Florida and was scheduled to be delivered to HVRA's New Milford office in June of 2006. The departure and transport of this unit was delayed "due to holidays and the fact that permits and police escorts were required to travel through certain states" and that "travel through those and other states was restricted to certain days."
- 2. The unit left Florida on July 6, 2006 and did not arrive in Connecticut until July 26, 2006.
- 3. HVRA provided OHCA with an image generated by the New Milford MRI unit on June 20, 2006. The MRI unit was not located within the State of Connecticut when this image was taken.
- 4. The first patient was scanned on the New Milford MRI unit on September 13, 2006.

Based on the information available to OHCA, OHCA herein determines that Housatonic Valley Radiological Associates, P.C. is not exempted from Certificate of Need under the provisions of Section 3 of Public Act No. 06-28 as HVRA did not provide evidence that the "equipment was in operation on or before July 1, 2006" as required by this law.

As such, OHCA determines that HVRA is required to file a Certificate of Need authorization pursuant to 19a-639 of the Connecticut General Statutes, as amended by Public Acts 05-93 and 06-28. OHCA considers the submission of information received on September 29, 2006 as the Letter of Intent for this matter; therefore, HVRA may file a completed CON application with OHCA between **November 28, 2006** and **January 27, 2006**. The CON application is being mailed to your attention separately.
