Termination of 15 Intermediate and Long Term Treatment and Rehabilitation Beds for Substance Abuse Clients in Bridgeport

Dear Ms. Marcano:

The Office of Health Care Access ("OHCA") is in receipt of your request for exemption from the Certificate of Need ("CON") process, pursuant to Section 17a-678 of the Connecticut General Statutes ("C.G.S."), to terminate its residential long term care license for substance abuse clients at 1124 Iranistan Avenue, Bridgeport, CT.

Upon review of the information contained in the request, OHCA finds the following:

- 1. Helping Hand Center, Inc. ("HHC") is a non-profit facility providing clinical, intermediate service level III.3 substance abuse residential long term treatment at 1124 Iranistan Avenue, Bridgeport, Connecticut. HHC receives funds from The Department of Mental Health and Addiction Services.
- 2. HHC is proposing to terminate its residential long term care license for substance abuse clients at 1124 Iranistan Avenue, Bridgeport, CT, and become a Recovery House.
- 3. The Department of Mental Health and Addiction Services ("DMHAS"), in a letter received October 3, 2007, from Deputy Commissioner Peter B. Rockholz, M.S.S.W., grants an exemption under CGS Section 17a-678 to allow Helping Hand Center, Inc. to terminate its residential long term care license for substance abuse clients at 1124 Iranistan Avenue, Bridgeport, serving the Southwest region.

- 4. DMHAS states that the termination of this program will not adversely affect service access to residential care in the region as there exists excess capacity within residential levels of care in the geographic region. Additionally most of Helping Hand Center's client population would more appropriately be served through stable outpatient services and transitional housing. Currently there are no Recovery Houses serving the Southwest Region.
- 5. The total capital expenditure associated with the proposal is \$250,000.

Based on the above findings, OHCA has determined that Helping Hand Center, Inc.'s request to terminate its 15 intermediate and long term treatment and rehabilitation beds for substance abuse clients at 1124 Iranistan Avenue, Bridgeport meets the exemption requirements of Section 17a-678 of the Connecticut General Statutes and, therefore, is exempt from OHCA's CON process.
