RE: Certificate of Need Determination Request; Report Number: 07-31062-DTR PTSMA, Inc., a subsidiary of Select Medical Corporation, d/b/a Select Physical Therapy Proposal to Relocate an Outpatient Rehabilitation Center in New Britain

## Dear Attorney Meng:

On November 7, 2007, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") Determination request on behalf of PTSMA, Inc., a subsidiary of Select Medical Corporation, d/b/a Select Physical Therapy. The request is for the relocation of an outpatient rehabilitation center from One Liberty Street to One Lake Street in New Britain, Connecticut. Please be advised that OHCA has reviewed your request and makes the following findings:

- 1. PTSMA, Inc. d/b/a Select Physical Therapy ("Petitioner") operates an outpatient rehabilitation center at One Liberty Street in New Britain, Connecticut.
- 2. PTSMA, Inc. is a wholly owned subsidiary of Select Physical Therapy Holdings, Inc., which in turn is a wholly owned subsidiary of Select Medical Corporation.
- 3. Select Medical Corporation became the owner of 32 outpatient rehabilitation centers in Connecticut, which includes Select Physical Therapy in New Britain, on November 1, 2007.
- 4. The Petitioner is requesting a relocation of its New Britain outpatient rehabilitation center, from One Liberty Street to One Lake Street in New Britain.
- 5. The relocation will allow the center to continue to provide area residents with outpatient rehabilitation services.

- 6. The Petitioner's service area and target population will not change as a result of the relocation.
- 7. No additional services are proposed and no services will be terminated.
- 8. There is no capital expenditure associated with this relocation.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for you to proceed with the relocation of the outpatient rehabilitation center from One Liberty Street in New Britain, Connecticut to One Lake Street in New Britain, Connecticut.
