Dear Mr. Spinelli:

On January 25, 2008, the Office of Health Care Access ("OHCA") received your application for exemption from the Certificate of Need ("CON") process for the establishment of a psychiatric outpatient clinic for adults in Bridgeport, Stamford and Stratford, Connecticut.

Please be advised that OHCA has reviewed the information submitted in your request and makes the following findings:

- 1. Optimus Health Care, Inc. ("OHC") d/b/a Bridgeport Community Health Center is a private, non-profit, Federally Qualified Health Center ("FQHC") located at 982 East Main Street, Bridgeport, Connecticut.
- 2. Optimus Health Care, Inc., d/b/a Bridgeport Health Care Center is proposing to establish a psychiatric outpatient clinic for adults at the following locations:
 - Bridgeport Community Mental Health Center, 982 East Street, Bridgeport,
 - Bridgeport Community Mental Health Center, 471 Barnum Avenue, Bridgeport,
 - Park City Primary Care Center, 64 Black Rock Avenue, Bridgeport,
 - Ralphola Taylor Community Health Center, 790 Central Avenue, Bridgeport,
 - Stamford Community Health Center, 137 Henry Street, Stamford,
 - Stamford Community Health Center, 245 Selleck Street, Stamford, and
 - Stratford Community Health Center, 727 Honeyspot Road, Stratford.

- 3. The Department of Mental Health and Addiction Services ("DMHAS"), in a letter dated January 23, 2008, from Deputy Commissioner Peter B. Rockholz, M.S.S.W., recommends an exemption under CGS Section 19a-639b for Optimus Health Care, Inc. to provide psychiatric outpatient treatment services for adults at the above locations.
- 4. DMHAS states that these seven sites will serve Bridgeport, Stamford and Stratford. Optimus is a Federally Qualified Health Center providing one stop shopping for primary care and mental health services. Optimus Health Center, Inc. plans to provide mental health outpatient services to a total of 2,475 clients, serving 2,000 clients in Bridgeport, 356 clients in Stamford and 119 clients in Stratford.
- 5. There is no capital expenditure associated with this proposal.

Based on the above findings, OHCA has determined that Optimus Health Care, Inc. d/b/a Bridgeport Community Health Center's request to establish psychiatric outpatient clinics for adults at the seven locations listed above meets the exemption requirements of Sections 19a-639b of the Connecticut General Statutes and, therefore, is exempt from OHCA's CON process. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
