Dear Ms. Dreger:

On April 30, 2009, the Office of Health Care Access ("OHCA") received your Certificate of Need ("CON") Determination request concerning the proposal of Catholic Charities and Family Services, Diocese of Norwich, Inc. for the relocation of its services from 22 Masonic Street in New London to 28 Huntington Street in New London, Connecticut. OHCA has reviewed the information contained in your CON Determination request letter and makes the following findings:

1. Catholic Charities and Family Services, Diocese of Norwich, Inc. ("CCFSDN") is a non-profit facility providing outpatient psychiatric treatment for children and substance abuse treatment services at 22 Masonic Street in New London.
2. CCFSDN is proposing to relocate its existing licensed services from 22 Masonic Street in New London, to 28 Huntington Street in New London, Connecticut.
3. The 22 Masonic Street office of CCFSDN is currently licensed as follows:
 - Facility for the Care or Treatment of Substance Abusive or Dependent Persons (DPH), and
 - Outpatient Psychiatric Clinic for Children (DCF).
4. The service area and target population will not change as a result of the relocation of the existing licensed services.
5. No additional programs are proposed and no services will be terminated.



6. The total capital expenditure associated with this relocation is \$5,000.

Based on these findings, OHCA has determined that Certificate of Need approval is not required for Catholic Charities and Family Services, Diocese of Norwich, Inc. to proceed with the relocation of its existing licensed services from 22 Masonic Street in New London to 28 Huntington Street in New London, Connecticut. Termination of these services would require CON approval, pursuant to Section 19a-638, C.G.S.
