On October 15, 2012, the Department of Public Health ("DPH"), Office of Health Care Access ("OHCA"), received your request to extend the expiration date of the CON rendered under Docket Number: 08-31187-CON, for Yale-New Haven Hospital's facilities project to modernize its Adult Emergency Department and to acquire a CT Scanner for use in Emergency Department trauma cases.

Condition #1 within the Final Decision's Order under Docket Number: 08-31187-CON states:
