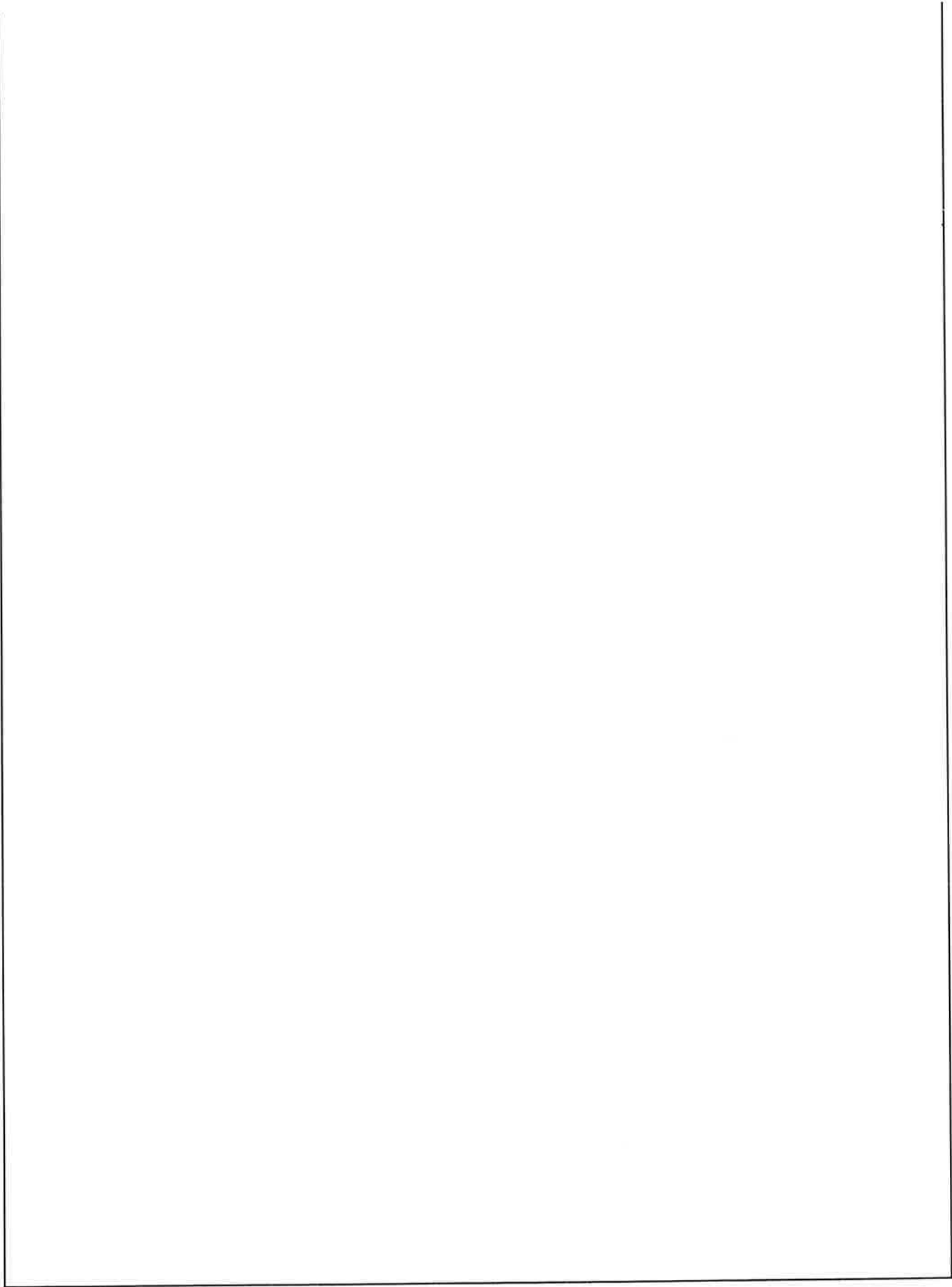

Effective on January 1, 2017 (the "Effective Date"), Medical Oncology and Blood Disorders, LLP ("MOBD") is joining its medical practice with Regional Cancer Care Associates LLC, a New Jersey limited liability company that was qualified to do business in Connecticut on September 14, 2016 ("RCCA"). RCCA is owned 100% by licensed physicians. MOBD will transfer substantially all of the assets of its medical practice to RCCA (or an affiliate of RCCA) pursuant to the terms of an Asset Purchase Agreement, which is still being finalized. On the Effective Date, the physician partners of MOBD will become members of RCCA. All of the physicians formerly with MOBD will continue to operate their medical practice and provide oncology/hematology medical services to patients at their current office locations in Manchester and Hartford as part of RCCA after the Effective Date.
