An overview was provided of the charges that were addressed in the report and how they intersect with health.</li> <li>A video from the City of New Haven regarding tropical storm Elsa and flooding issues was shared with the group. It was noted that the drainage system was overwhelmed by the heavy rainfall. It was mentioned that climate change production shows us to expect more frequent rainfall in the same amount. A concern is that storm water flooding on a more regular basis could overwhelm drainage systems. Another concern is a sea level rise. Coordinated mitigation could help to address these issues.</li> <li>There was a question about the connection of the work. The environment has a big impact on our health.
