

Approval of the Minutes

Review Design Group Goals & Structure

Public Act 17-74

The director of the state innovation model initiative program management office shall, within available resources and in consultation with the Community Health Worker Advisory Committee established by such office and the Commissioner of Public Health,

- > study the feasibility of creating a certification program for community health workers.
- > Such study shall examine the fiscal impact of implementing such a certification program and include recommendations for
 - (1) requirements for certification and renewal of certification of community health workers, including any training, experience or continuing education requirements,
 - (2) methods for administering a certification program, including a certification application, a standardized assessment of experience, knowledge and skills, and an electronic registry, and
 - (3) requirements for recognizing training program curricula that are sufficient to satisfy the requirements of certification.

Review Model States

Rhode Island: Requirements for Certification

EXPERIENCE: Six months of full-time experience or 1000 hours of experience specific to the domains (competencies) within the past five years. Experience may be paid or volunteer. Employer must attest to this.

SUPERVISION: 50 hours specific to the domains (competencies)

EDUCATION: 70 hours of education relevant to the domains.

PORTFOLIO: Must submit a collection of personal and professional activities and achievements any in 3 of 8 categories: 1) community activities, 2) research activities, 3) college courses or training, 4) community publications & projects, 5) description of professional experience, 6) awards, 7) resume/CV, 8) performance evaluation

CODE OF ETHICAL CONDUCT: Must agree to abide by this code

EXAM: None

Massachusetts: Requirements for Certification

EXPERIENCE: 2000 hours of professional work experience as a Community Health Worker whose documented job duties include each of the 10 core competencies in the past 10 years

REFERENCES: Submit references from at least three individuals; among them they must deem the applicant competent in each of the 10 core competencies

EDUCATION: certificate of completion from a Board-approved Community Health Worker Education and Training Program, including at least 48 hours of instruction. At least 38 hours of training in core competencies and at least 10 hours on specific health topics

CODE OF ETHICAL CONDUCT: Must agree to abide by this code

EXAM: None

Florida: Requirements for Certification

EXPERIENCE: 500 hours of formal work and/or volunteer experience providing community health worker services in the domains of: 1. Communication and Education, 2) Resources, 3. Advocacy. Employer must attest to this.

RECOMMENDATIONS: Submit 3 letters of recommendation. One letter must be from an individual who supervised the applicant's paid or volunteer work in the field, 2 letters can be character/personal recommendations

EDUCATION: High School Diploma, General Equivalency Degree or higher plus 30 hours of training in Communication and Education (4 hours), Resources (4), Advocacy (4), Foundations of Health (4), Professional Responsibility (4), Electives (10 hours)

CODE OF ETHICAL CONDUCT: Must agree to abide by this code

EXAM: 100-item, multiple choice test

Texas: Requirements for Certification

EXPERIENCE: At least 1000 cumulative hours of community health work services within the most recent six years. Applicants check off which of 16 job duties they perform. Employer must attest to this.

OR

EDUCATION: Completion of an approved 160-hour competency-based training program certified by Texas Department of State Health Services

CODE OF CONDUCT: Must agree to abide by Texas Health and Safety Code

EXAM: None
