	She said that there is a lot happening at OHS. Part of the question is what CAB should know

	information from Laura? Does CAB want a weekly, bi-weekly, or monthly email? Terry			
	Nowakowski said that's onerous – that would be a lot to ask a	nyone.		




- Robert Krzys thinks this is an important topic, but in the interim, by putting on every monthly agenda of OHS, to have item for "OHS update." Also, once we have the meeting with Vicki Veltri – OHS Director, and Community Catalyst, we can have a revisit the communication system set up. For now, let's just touch base once a month at meetings
- Laura Morris said that there are currently no PCM engagements, but OHS will share events that are happening. Laura Morris talked about listening sessions that are happening, including those organized by Office of Early Childhood, Health Equity Solutions, etc.
  - Velandy Manohar said there is a vocabulary gap that there is a 30,000 word gap by pre-K. Thinks that thousands of families have no books in their homes. So, we have to make a massive effort on the literacy gap. Otherwise we will never help children catch up. If the books aren't there, the vocabulary won't catch up.
  - Leslie Greer said she shared a newsletter link and all events are updated weekly. If CAB wants her to send out the link again. Jason Prignoli subscribes to newsletter and said it is helpful information.
  - Denise Smith agreed that the newsletter is useful and timely. But she said that getting the information in advance is helpful for her to draw community members and more voices into the discussion.
  - Robert Krzys said this issue is a function of the feedback loop.
- Laura said that there are no scheduled PCM engagements and the role of CAB is to disseminate information, but we also want to hear from each CAB member their thoughts on that specific consumer engagement or in general.
  - Robert Krzys asked whether Freedman consultant Vinayak Sinha is on the phone and asked him about reports generated, that might be available to CAB.
  - Vinayak Sinha said there is no final report. Just put together information gathered at that point into a compendium for the design groups. This was compiled in response to CAB questions. Robert Krzys thinks it would be useful to get these reports and this information.
  - Velandy Manohar said that some conclusions were made in some groups. There was some consensus on those groups. Vinayak Sinha agreed and said this information was considered and incorporated into the PCM model – which was organized in the compendium referred to.
  - Denise Smith wanted to confirm that we are discussing 30+ documents on the OHS website. Vinayak Sinha said this compendium is one document, 30+ pages. We are also discussing the two-pager for each design group and some other documents, like the concept map.
- Laura Morris said in reference to whether CAB added value Laura wanted to address this question by sharing those documents.
  - Vinayak Sinha said he has not gone back to practice transformation task force with more discussions. Velandy Manohar said he would be delighted to help out.
- Laura Morris said in response to the question about CTN and whether there is a way to engage them more, she asked Leslie Greer to look into this. Leslie Greer said we'd have to ask the producer to tape CAB meetings, and she would have to give them a date (a month in

advance to get on the calendar to have meetings recorded). Robert Krzys said Leslie Greer should do this for future CAB meetings since we have the dates set for 2020 (just not the time or location).

- Laura Morris addressed the question of whether CAB is OHS or something else. She said she would defer to Executive Director Veltri to answer this question on 10/23
- Going to July questions: Laura Morris said that the organizational chart is completed and is being reviewed. Executive Director Veltri will share this at the special meeting on 10/23
- Laura Morris said the process for communicating with OHS involves Robert Krzys and encouraged CAB members to reach out directly to her. She also said she reaches out periodically to CAB members, and it's good to have an open door policy.
- Robert Krzys said that he has not sent out the survey and wants to connect with Amplify consultant to do this anonymously and to share the survey information.
- Laura Morris said that the healthcare cabinet was established to inform the Governor and Lt. Governor, and continues to do so under the new administration. Depending on what they are working on – they will look at a lot of different administrative initiatives, increase transparency, and promote consumer engagement and education. Today's meeting involved CT Insurance Department giving a presentation on increases in the plan premiums, and Access Health gave a presentation on their open enrollment, starting next month. Now that we have the APCD (All Payers Claim Database) – this will be reported out to healthcare cabinet and they will drill it down even further to help them further address health access, equity, etc. And hopefully health affordability.
  - Robert Krzys said we have not filled our slot on the healthcare cabinet, so if anyone wants to be involved – this is a heavy lift. There is a tremendous amount of issues that come into and go from that place. But if there's a member interested in being appointed, please come forward.
  - Laura Morris showed the group links to the healthcare cabinet she said that on the OHS website, all the documents are posted, and cost containment studies are all there. As well as reports from last month and APCD too. She will send the links out to everyone.
  - Terry Nowakowski said OHS has two new things: expenditures compared, and also satisfaction of consumers. Laura Morris said today, OHS launched the cost estimator tool.
- Laura Morris discussed what councils and workgroups are doing by sharing an excel spreadsheet and lists of all the consumer representatives, work groups, etc. She will also share these lists with everyone.
  - Terry Nowakowski said that CHW committee is actively looking for CHWs as new members. Laura Morris will send out this information, so people know what that committee is looking for in terms of membership.
  - Velandy Manohar is making a plea that an older adult join a committee.
- Laura Morris addressed the last question saying this will be discussed by Executive Director Veltri at the special meeting.
- Laura Morris said it would be difficult to co-locate CAB in HEC. This is a joint collaboration with OHS and the Department of Public Health.
