requested copies of the Declaration Statements of Conflict-of-Interest by CTMHP principals of the work

done in the above two reports. It is a requirement of US HHS: 'Responsibility of Applicants for Promoting

Objectivity in Research for Public Health Service Funding' regulations. I believe these CLAS reports are the

only current empirical assessments of 'Culture Competency' within Connecticut's health organizations -

a fiduciary responsibility to also show diligence and integrity.

I would like to close with a quote from Dr. Francis Collins, Director of the National Institutes of Health

and a noted leader of the Human Genome Project - "The public trust in what we do is just essential, and

we cannot afford to take any chances with the integrity of the research process."
