Size of Quality Council Measure Set

The Council discussed the size of the measure set. The current set has 42 measures, not counting care experience, which includes four to six domains. Faina Dookh, of the PMO, reviewed over states' measure sets. The main focus is alignment, which is why the Council considered alignment with the Medicare Shared Savings Program and the Physician Quality Reporting System in its decision making process. The Council also looked at the State Employee Health Care Plan (27 measures) and the Medicaid PCMH measure set (between 10 to 15 adult and 10 to 15 pediatric measures with overlap). It was noted that the measure set will likely look different after the public comment period, particularly as they take issues such as feasibility or utility into account.

Quality Measure Alignment Plan: Health Plan Interviews

Dr. Schaefer reviewed feedback received to date from meetings with the health plans. The payers have expressed interest in knowing the top priority measures so they can begin to include that information in their 2017 contracts.

Meeting Schedule/Next Steps

Dr. Schaefer reviewed next steps. The Council will meet on October 21 to review the draft report and examine health equity. The PMO will work to schedule a conference call on care coordination in lieu of the meeting scheduled for that evening. That call will be open to all.
