▶ Timeline for remaining activities

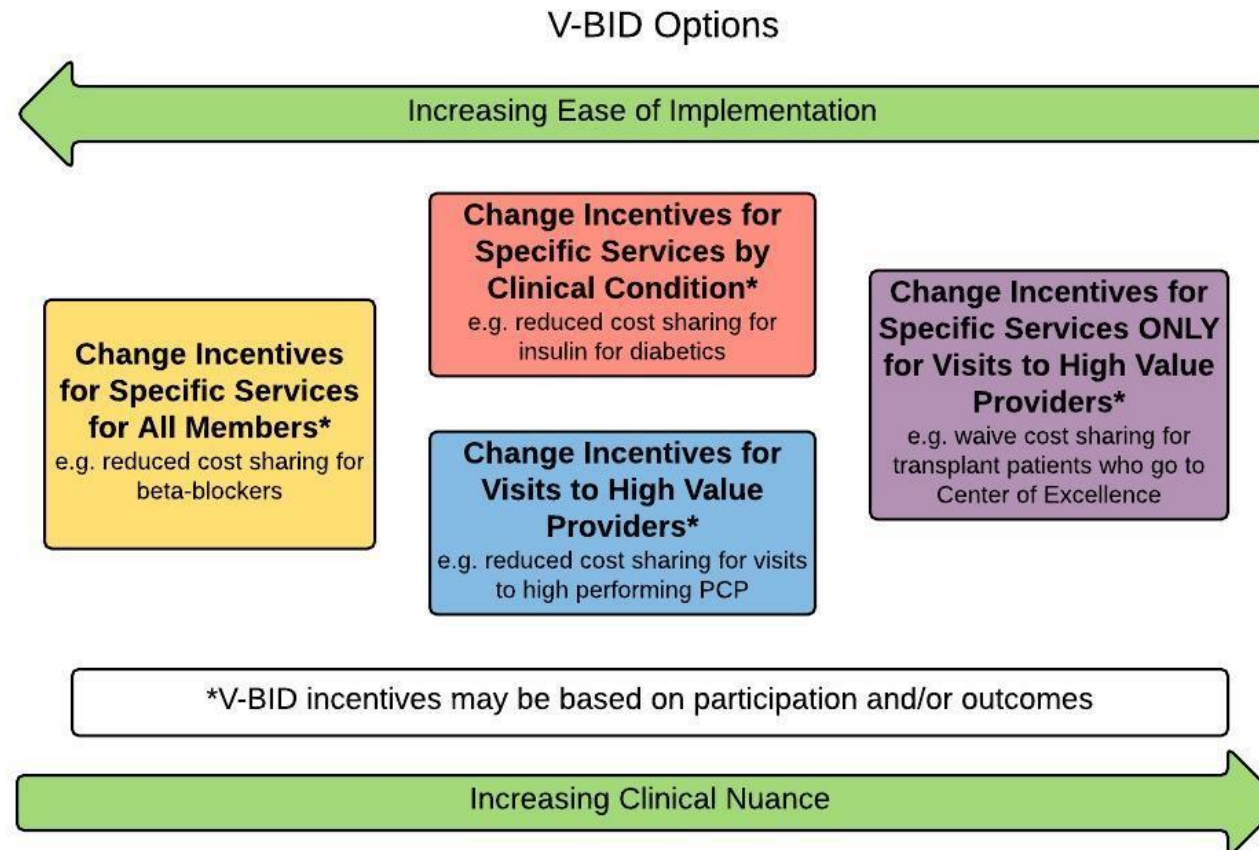
- May 12th - Focus group with employers

- ▶ Applicable Employer Types
- ▶ Recommended V-BID Components
 - Recommended Core Benefit Plan Designs
 - Recommended Conditions to target
 - Recommended Incentive Structure(s)
- ▶ Justification for Recommendations
 - Expert opinion, Consortium/stakeholder feedback, SWOT, research/evidence-base, employers' experiences
- ▶ Additional V-BID Components/Benefits to Consider
- ▶ Examples of Employers who have Implemented V-BID Plans
