- Nonprofit Employment and Training Work Group

Recommendations on Governor's Nonprofit Grant Program:

A recommendation was brought forward by the Contract Procurement and Administration Work Group to increase the bond for the Nonprofit Grant Program from \$10 million to \$25 million.

Nonprofit Collaboration Incentive Grant:

A recommendation was brought forward to allocate \$5 million to the Nonprofit Collaboration Incentive Grant.

• This recommendation was tabled to allow time for the Work Groups to complete an evaluation on how previous grant money was spent. Information will be presented at the next Cabinet meeting.

Other business:

A follow- up on the previous work competed by the Cabinet on Principles of Partnership was requested.

• A discussion will be held on this subject at the next Cabinet meeting.
