### **First Day** of Employment

1) Complete the following forms and submit to the Human Resources Manager:

- ✓ Emergency Contact and Name & Address Change Form
- ✓ <u>Disability, Reporting of</u>
- ✓ Special Needs
- ✓ Parking Permit Application
- ✓ <u>Electronic Card Key Access</u>
- 2) Read the <u>Acceptable Use of State Systems Policy</u> and the <u>Addendum</u> and then complete <u>Internet Access</u> and <u>Security for Mobile Computing and Storage</u>

  <u>Device training</u> in order to get access to the Internet and email.
  - ➤ Upon completion of these trainings, submit the certificate of completion forms to the Information Technology Unit on the third floor.
- 3) Complete the **Ethics Training at OSE website**.
  - Upon completing this training, submit the certificate of completion form to the Human Resources Unit.
- 4) Read Public Records Policy 05: <u>Disposition of Public Records</u>.
  - Upon completion of reading this policy, submit the <u>Records Retention</u> <u>Disposition Policy Acknowledgement</u> of Receipt form to the Human Resources Unit.
- 5) If you are new to state service, review the <u>Employees Health Care Options</u> <u>Planner</u>.
  - You must complete and submit a Benefit Enrollment form to the Benefits and Payroll Unit within 30 days of employment. The

Benefits and Payroll Unit, Charese Bozeman, will be reaching out to you to complete the required paperwork.

- 6) Review information on <u>Supplemental Benefits</u>
  - > You may be subject to evidence of insurability guidelines if you do not sign up for certain insurance products when you are first eligible and decide to enroll later.
- 7) If you are new to state service you are a member of the Tier IV Retirement Plan. Currently there is not a Tier IV Plan Summary available from the Office of the State Comptroller. General information on the Defined Contribution component of the Tier IV Plan can be found by clicking <a href="here">here</a>.
- 8) Complete <u>Flex-time Request Form</u> and submit to your supervisor, if your hours will <u>not</u> be 8:00 a.m. to 5:00 p.m. Monday through Friday with one (1) unpaid hour for lunch.
- 9) Obtain photo identification:
  - ▶ Obtain signature of OPM's Human Resources Manager on the Photo ID Request Form, and bring the approved form to the Department of Administrative Services (DAS), located in downtown Hartford, 450 Columbus Boulevard, to obtain your photo identification. Directions to their office can be found via google maps. Please be sure to call DAS directly at (860) 713-5555 to make arrangements.
- 10) Complete <u>Designation of Retirement Plan Election Form</u> (Form CO-931) and submit to the Human Resources Unit. If you are new to state service complete the <u>Designation of Retirement Plan Beneficiary Form</u> (CO-999) and submit to the Human Resources unit.
- 11) If you are new to state service, complete

  Retirement Credit Purchase Request for Prior Miscellaneous Services (Form CO-991) and submit to the Human Resources Unit.
- 12) Complete and submit the following forms to the Benefits and Payroll Unit on the second floor, if you are new to state service or transferring from another state agency and want to make changes.

- ✓ <u>Employee's Withholding Allowance Certificate</u> (Form W-4)

  Before you submit the W-4 Form be sure you have read this <u>W-4 Notice</u>.
- ✓ <u>Employee's Withholding Certificate</u> (Form CT W-4)
- ✓ <u>Direct Deposit Authorization and Input</u> (Form CO-1040)
- ✓ Health Enhancement Enrollment Form (Form CO-1314)
- ✓ Retiree Health Fund Enrollment (Form CO-1300B)
- 13) Complete Electronic Security Awareness Training.
  - You will receive an e-mail inviting you to take this training.
- 14) Read <u>24 policies and procedures</u>.
- 15) Upon completion of reading the required policies and procedures and fulfilling the required training requirements, please complete the applicable forms included herein.

#### Within **Six Months** of Employment

Complete the following training, which will be coordinated for you unless documentation can be provided that you have taken this training with a previous employer.
