- A. At the February 1, 2017 meeting of the State Bond Commission funds were allocated to provide a grant-in-aid to the Capitol Region Council of Governments for a foundation testing program to assist homeowners in the northeastern part of the state who are concerned due to the possible existence of a mineral that could cause home foundations to deteriorate.

Under this program, homeowners will be eligible for a 50% reimbursement, up to \$2,000, for pyrrhotite testing of two core samples within their home's foundation. Homeowners who have already experienced foundation deterioration may choose to have a licensed inspector make a visual inspection of the foundation. Visual inspections will be 100% reimbursed up to \$400.

This program was originally limited to testing for all applicants with houses built since 1983 within a 20 mile radius of the J.J. Mottes Concrete Company in Stafford Springs.

The purpose of this request is to allow the Commissioner of Housing to approve waiver requests for testing in any other part of the state.
