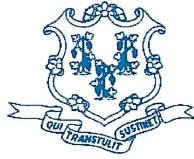

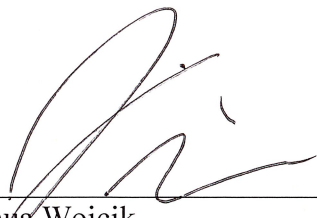

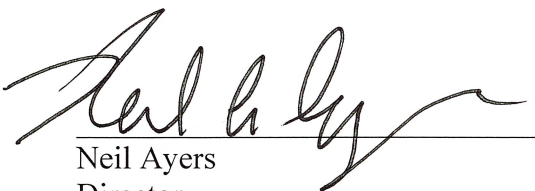
Ladies and Gentlemen:
