Each year the Department requests for all federal awards that a Receivable account be established in anticipation of Federal Funding. This request is submitted to the Office of Policy and Management, Budget and Financial Management Division for their approval. The request identifies which Federal funded award is being requested for the Receivable and documentation of the anticipated award is provided as back up. This Receivable allows the Department to utilize state funds for payments while we wait funding from the Federal award. Once funding is received by the Department for the Federal award, a drawn down of the Federal funds is completed and the state Receivable funds are reimbursed. This process allows the Department the ability to make timely payments to their contracted providers receiving the Federal funds.

All of our current Federal awards have a Receivable established which would allow the Department the ability to continue paying our Contractors during the potential shutdown.
