The total state funding level of the program is \$174,886. The Department of Agriculture has suggested a 10% reduction in the state appropriated portion of this program, with strong reservations. This amounts to a reduction of \$17,489. While reductions can be made to this program, they cannot be made without a direct reduction to the clients that the programs serve. We anticipate that a 10% reduction would result in 922 clients being eliminated from the program, or roughly 2% of the enrolled population.
