Please find the Department of Housing's (DOH) proposed reductions attached to this email. The Department appreciates the Governor's financial commitment to creating and preserving affordable housing in Connecticut and we are striving to administer our programs as efficiently as possible. We believe these cuts can be made without directly impacting services or funding to an individual, household, municipality, housing authority, or affordable housing project or program. Please note that our reduction percentage is skewed by the inclusion of the Renter's Rebate program. As you know, that program is still administered by OPM, but DOH was instructed to include it in our budget total. DOH's actual reduction percentage (without Renter's Rebate) is 4.47%.
