Operating Budget Technical Adjustments FY2017

In response to the August 11, 2015 letter and instructions, UConn Health respectfully requests a FY17 budgetary adjustment for the reasons specified below. These are technical adjustments resulting from legislation passed during this last session that require a change in resources that is unrecognized by the enacted budget for FY 2017. Specifically:

- Subsection (k) of Section 13 of <u>Public Act 15-146</u>, An Act Concerning Hospitals, Insurers and Health Care Consumers, bars hospitals, health systems and hospital-based facilities from collecting a facility fee for outpatient health care services that use a current procedural terminology evaluation and management code and are provided at an off-campus hospital-based facility other than an emergency department. UConn Health expects to recover \$1.7 million less in annual revenue as a result of this provision. As this prohibition goes into effect on January 1, 2017, the impact of this legislation on UConn Health's budget will be \$850,000 in FY 17.
- Public Act 15-4, An Act Concerning Excessive Use of Force, requires among other things, that on and after July 1, 2016 each sworn member of the State Police, municipal police force, and Higher Ed Special Police Forces use body-worn recording equipment while interacting with the public in a law enforcement capacity. Police officers must also be trained on the use of such equipment, among other training requirements in the new law, and store the data captured by the recording equipment so that the data can be accessed and used in specified circumstances. UConn Health estimates that compliance with this Public Act will cost us at least \$31,000 in one-time equipment costs plus an additional \$25,000 per year annually. While the fiscal note on this bill recognized that higher education law enforcement agencies would incur costs to comply, the legislation and the FY17 budget did not provide funding or a funding mechanism for the colleges.
