Subject: Items for the FAC Meeting for October 1, 2008

Items numbered 2009-1 and 2009-2 have been reviewed by this office and additional information has been provided where it was considered to be helpful in more fully understanding the item.

2009-01 Department of Information Technology/Various Other Agencies

Section 39 of PA 07-1 of the June Special Session provides the Department of Information Technology with the authority to adjust mainframe service rates.

This FAC will reallocate IT funding among affected General Fund agencies to reflect the new rate schedule. The new rates will be retroactive to July 1, 2008.

The new rate schedule will not result in either a loss or a gain to the State, but it will provide for a more precise distribution of charges for IT services across State agencies. Moreover, this new schedule will provide for more accurate claiming of reimbursement for participating state agencies.

The FY 09 agency appropriations for IT services were based on the old rate schedule that has been in place for many years.

A spreadsheet detailing funds being proposed for reallocation to or from agencies is presented below.
