Subject: Items for the Finance Advisory Committee meeting for January 27, 2010

Items 2010-5 through 2010-10 have been reviewed by this office and the following information has been provided to more fully understand the items:

2010-5 Department of Social Services

This is a re-submission of Item 2010-5 from the January 14, 2010 meeting of the Finance Advisory Committee, which did not pass.

The Department of Social Services requests a transfer of \$20.2 million from the Medicaid (\$20.1 million) and Housing/Homeless Services (\$107,300) accounts to the State Food Stamp Supplement (\$150,000), Charter Oak Health Plan (\$8.5 million), ConnPACE (\$11.4 million), and Services to the Elderly (\$107,300) accounts.

Funds are necessary in the State Food Stamp Supplement and Charter Oak Health Plan accounts due to significantly higher than projected caseloads in the first half of the fiscal year. Funds are necessary in ConnPACE due to a slower than anticipated transfer of ConnPACE clients to the Medicare Savings Programs. The transfer of funds between Housing/Homeless Services and Services to the Elderly is a technical change.

It should be noted that although \$20.1 million is requested to be transferred out of the Medicaid account, we are currently projecting a year-end deficiency of \$70.0 million in this account.

2010-6 Commission on Aging

The Commission on Aging (CoA) requests a transfer of \$25,622 from Other Expenses to Personal Services. PA 09-3 JSS reduced the commission's FY 10 budget by 53%. In order to meet their FY 10 budget the commission significantly reduced the work hours of its employees. The additional funds are needed in Personal Services to make payroll.

2010-7 Permanent Commission on the Status of Women

The Permanent Commission on the Status of Women (PCSW) requests a transfer of \$100,000 from Other Expenses to Personal Services. PA 09-3 JSS reduced the commission's FY 10 budget by 55%. In order to meet their FY 10 budget the commission laid off three employees and significantly reduced the work schedules of the remaining six employees. The additional funds are needed in Personal Services to make payroll.

2010-8 Commission on Children

The Commission on Children (CoC) requests a transfer of \$60,000 from Other Expenses to Personal Services. PA 09-3 JSS reduced the commission's FY 10 budget by 53%. In order to meet their FY 10 budget the commission reduced its employees' work schedules. The additional funds are needed in Personal Services to make payroll.

2010-9 African-American Affairs Commission

The African-American Affairs Commission (AAAC) requests a transfer of \$18,778 from Other Expenses to Personal Services. PA 09-3 JSS reduced the commission's FY 10 budget by 52%. In order to meet their FY 10 budget the commission laid off two employees and the remaining employees took salary reductions. The additional funds are needed in Personal Services to make payroll.

2010-10 Latino and Puerto Rican Affairs Commission

The Latino and Puerto Rican Affairs Commission (LPRAC) requests a transfer of \$10,000 from Personal Services to Other Expenses. PA 09-7 of the September Special Session, the general government implementer, increased the number of Commissioners from 13 to 21 and included additional community outreach tasks. The increased number of Commissioners together with the increased duties of the Commission requires additional funding in Other Expenses, for items such as mileage reimbursement and postage.

Actual expenditures in FY 09 and appropriations for the Commissions in FY 10 are presented in the table on the following page.
