

CRIMINAL JUSTICE POLICY ADVISORY COMMISSION (CJPAC) DRAFT MINUTES

4. Discussion of January Monthly Indicators Report from Kyle Baudoin, Policy Development Coordinator, Criminal Justice Policy and Planning Division, Office of Policy and Management

Baudoin presented the February Monthly Indicators Report.

The “Prison Population Forecast” section captures the yawning gap between OPM’s forecast and the DOC population beginning in March 2020 with the onset of the COVID-19 pandemic. Since August, the decreases have attenuated, suggesting a return to typical patterns. OPM remains eager to see whether this January, as has been the case most years, the population ticks up with a boost of newly sentenced people, a phenomenon that has been referred to as the “January bump” in the *Monthly Indicators Report*.

Chart 2a contains analysis of DOC admissions and exits between 2017 and 2020. For most months, release events mirror admissions, resulting in modest change to the count of incarcerated individuals at any one time. The disruptive force of COVID-19 is evident in March and April 2020, however, when the careful balance was interrupted. Through July 2020, release events outpaced admissions, which shrank, dramatically, resulting in substantial correction population decreases. Beginning in August, the system, as has been the case in the past, restored a degree of stability. Once again admissions and release events began to mirror one another.

Members engaged in discussion about this month’s report.

5. Review and discussion of the Just and Well: Rethinking How States Approach Competence to Stand Trial

Dr. Norko delivered a presentation covering analysis of the October 2020 report from The Council of State Governments Justice Center. The presentation consisted of the definition of competence to stand trial and processes; highlights of the *Just and Well* report; 10 strategies recommended in the report and assessment of their fit for in Connecticut’s context; and overview of a possible pilot.

Members engaged in discussion about the report.
