Video Conferencing



Video Conferencing



- Video Conferencing allows court officials and others to see and converse with prisoners over video rather than in person.
- The CTDOC Video Conferencing Program provides state-wide access to the inmate population for criminal justice agencies at all levels.



Types of Hearings



- The type of hearings include but are not limited to: Parole, Criminal Court, Immigration, Social Security Administration, Psychiatric consultations, Probation, Civil Court, Family Court, District Courts, Out of State Correctional Facilities, and Out of State Parole hearings, enabling them to conduct their business in a more efficient manner.



Program Success



- The success of the CTDOC Video Conferencing Program can be measured through inter-agency cost effectiveness (expedites initial case processing, reduces court delay and eliminates a significant amount of prisoner transport), public safety and streamlined proceedings with all involved.



Evolution of Video Conferencing



- On May 8th 1996, the very first video conference was held at the Walker Correctional Facility.
- 15 inmates at Walker were heard via video with Rockville Court House for name changes. Name changes were a big deal for the inmates; it was a trip to court and out of the facility for the day.
- Once the inmates realized that they could no longer go to court but had the court come to them, the requests for name changes began to dwindle.



Evolution of Video Conferencing



- Today, there might be 1 or 2 hearings a year for name changes.
- On December 2nd, 1996 Northern Correctional Institution came online with Video Conferencing.
- In 1996 DOC held a total of 28 video conferencing hearings.



Evolution of Video Conferencing



- The 3rd quarter of 2000, video conferencing was introduced to Cheshire CI and Carl Robinson CI.
- In 2000 DOC held a total of 50 video conference hearings.
- In September 2008 video conferencing capabilities were added to the remaining 11 facilities.
- At that time DOC was averaging about 75 video conferencing hearings per month.



Video Conferencing Expansion

- In August 2009, DOC and Judicial collaborated on a Federal Grant proposal to expand video conferencing beyond its current capacity.
- The grant was awarded and the project kicked-off in October 2009.
- The intent is for Judicial to open up video conferencing capabilities at most court houses and increase the availability for the staff at Adult Probation.



Video Conference Expansion

- As a result DOC is in the process of adding at least one additional video conferencing machine to each facility.
- DOC is also working to update the data network to increase the bandwidth to handle the additional traffic that would be expected with the increase in the number of video conferences.



Video Conferences Today



- Today each DOC institution has video conferencing capability, a total of 18 units, and averages approximately 400 hearings a month.
- Almost half of those hearings are parole hearings.



DOC Community Release & Parole



DOC Community Release Packages



- The DOC currently uses a paper based system to review inmates for community release (Transitional Supervision, Halfway House, Re-Entry Furloughs, etc.).
- DOC release decisions are communicated to Parole and Community Services via both email and paper.
- Parole and Community Services then starts an electronic case file for the inmate's community supervision.



Parole Packages



- The Board of Pardons and Paroles uses the “Case Notes System” for all cases going in front of the Board for parole consideration.
- Case files are started electronically and serve as the foundation for community supervision by the DOC if the inmate is granted parole.



How is DOC information currently shared?

- The DOC currently electronically shares information to law enforcement via COLLECT (file 17 – supervised person, file 5 – wanted person, sex offender notifications to local police).
- This basic information requires law enforcement to directly contact the parole officer / DOC for more information.
- If detailed case information is requested, it must be sent manually.



How is DOC information currently shared?

- RT system access to other criminal justice agencies.
- DOC participates in the CT intelligence center which is an interagency collaborative involving federal, state and local law enforcement agencies.
- OBTS downloads information from the RT system
- General inmate info is on the DOC website
- Limited information sharing arrangements with other agencies (i.e. Parole to Probation program, DCF, DMHAS)



How is BOPP information currently shared?



- Any case that is approved for parole is sent electronically to the DOC Parole & Community Services.
- The current data sharing of information from Casenotes outside of the DOC is currently a paper based process and has to be initiated by a request.
- The limitations to our current system mean that there is no ability to generate reports or share the data electronically due to limitations on user licenses.



Enhancement of Casenotes

- The Board of Pardons and Paroles in partnership with the Department of Correction was awarded a \$600,000 ARRA grant in August 2009 to enhance the current Casenotes system.
- The Project is scheduled to be completed in the Spring of 2011.
- There are 3 main goals to the Casenotes Enhancement Project:



First Objective

- Create a platform that will allow the Department of Correction and the Board of Pardons and Paroles to electronically share detailed information with local law enforcement and other criminal justice agencies regarding supervised offenders in the community.



Second Objective

- To expand the existing Parole Case Notes Information System to facilitate the electronic processing of all inmates being considered by the DOC for any community release mechanism such as Transitional Supervision (TS), Halfway House (HWH), Re-Entry Furlough (REF) and Transitional Placement (TP).



Third Objective

- Develop the capability within the Case Notes System for ad-hoc and standard querying and reporting.



Future Information Sharing

- The specific information that will be available to other Criminal Justice agencies are going to be similar to the information shared on MA-JEB such as:
- Specific conditions of parole and DOC community releases will be available to criminal justice agencies electronically.
- The supervising parole officer's name and contact information will be available.



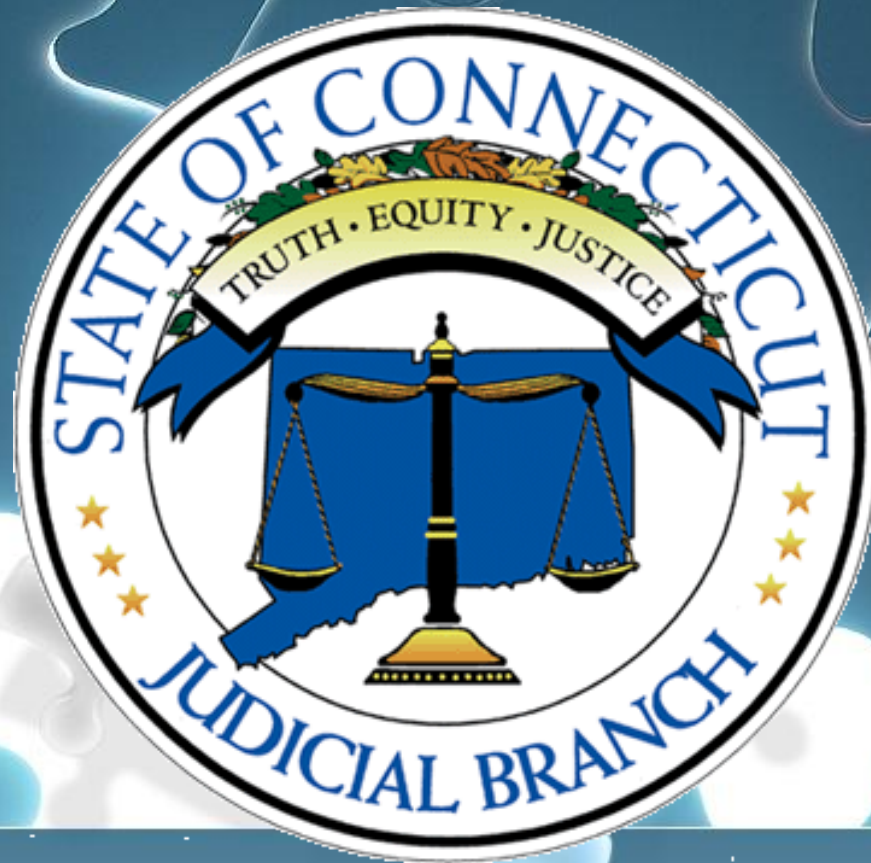
Future Information Sharing

- This case information will be shared with other criminal justice agencies which will increase officer, victim, and public safety as well as offender accountability.
- This upgraded system will also create a continuum of information flow from the point of incarceration to parole, DOC community release and probation supervision.



Future Information Sharing

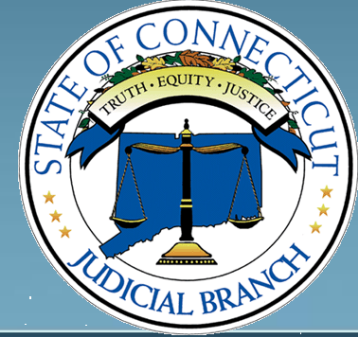
- Integration of new reporting functions will produce more accurate data to support cost effective management of facility discretionary release mechanisms.
- It will allow both agencies to respond more accurately and efficiently to Legislative inquiries, research inquiries, and other criminal justice entities.

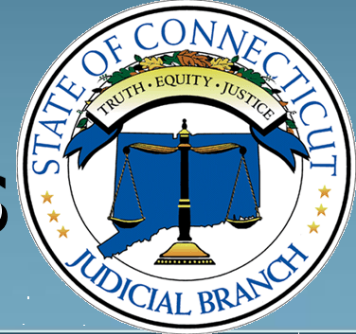
- Currently all Failure to Appear and Violation of Probation warrants are paperless
- Interface between CMIS/middleware/PRAWN
- Presently 6,500 warrants active with Adult Probation
- Probation staff are scanning in the warrant and affidavit into the system. This will allow police electronic access to the information.
- When the police serve the violation of probation warrant, they will be able to print the electronic copy and sign it as served.
- Prefill data / scanning application / data import

- Violation of Probations on the Internet

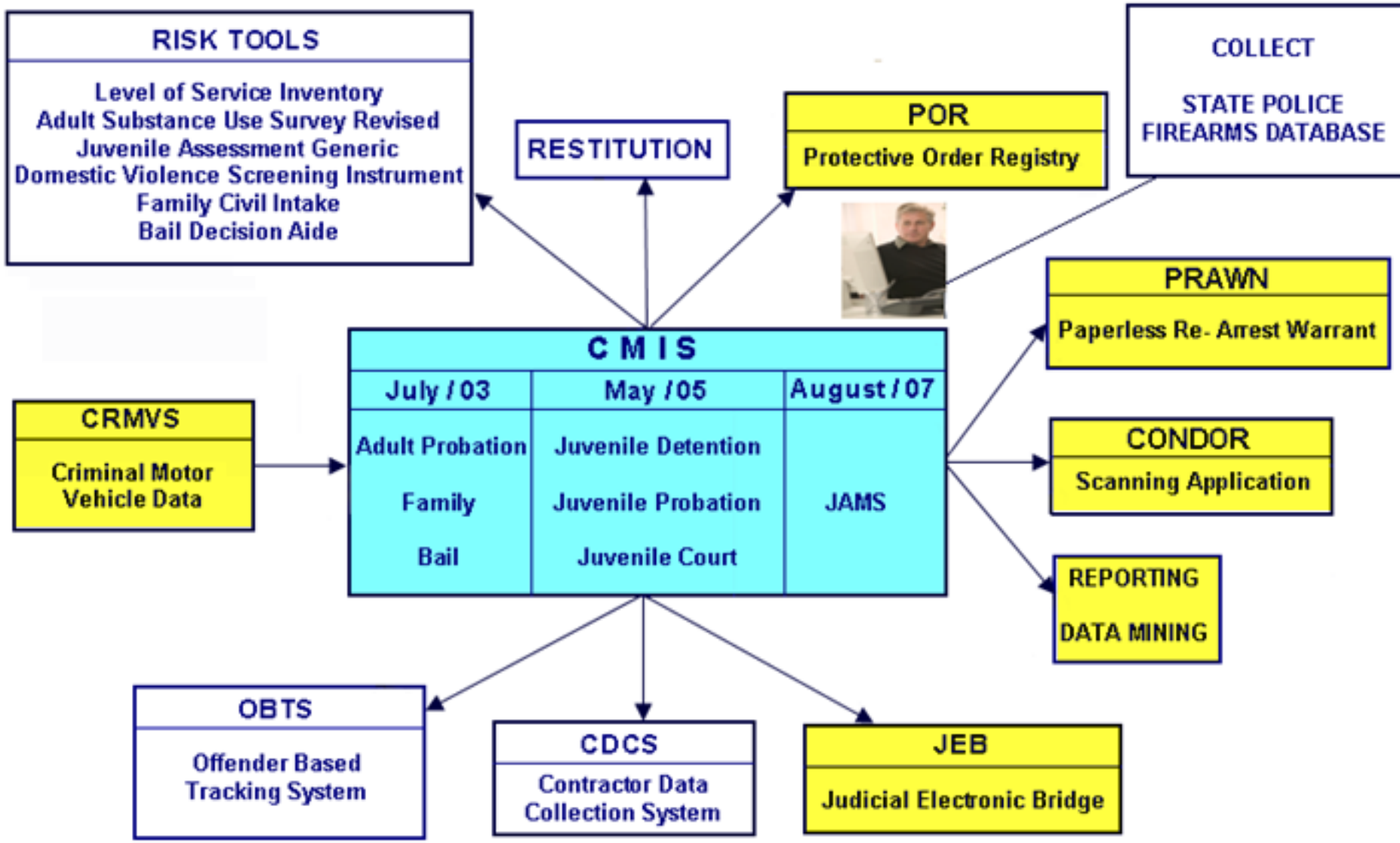
- Interface between CMIS/middleware/POR
- Data is more reliable by less data entry/more timely
- Domestic related cases - 30,000 a year

Data Mining, Integration of Data, Data Analysis



- Create datasets to facilitate program evaluation and longitudinal research
- Create datasets for external dissemination (e.g. Press inquiries, OFA, Parole, etc.)
- Interagency data exchange (e.g. split sentence offenders, Jail Reinterview, etc.)
- RBA legislation
- Provides real-time feedback to staff on performance objectives
- Efficient access to enable data-driven decision making at all levels
- Workload analysis and allocation
