## Numbers of Active Rearrest Warrants for Failure to Appear (FTA) and Active Warrants for Violation of Probation (VOP)

**Report:** This report is prepared by the Criminal Justice Policy and Planning Division, Connecticut Office of Policy and Management.

**Data:** The data in this report are from the Paperless Re-Arrest Warrant Network, known as PRAWN. The PRAWN system is maintained and operated by the Judicial Branch, Superior Court Operations Division, Office of the Chief Administrator.

**Definitions:** FTA means Failure to Appear on a criminal or motor vehicle proceeding.  
VOP means Violation of Probation.  
OTI means Order to Incarcerate  
Warrants with Law Enforcement Actions Noted means that a notation has been added on the detail warrant page  
Warrants Foreign Served means a warrant that is served by an agency that is not the issuing agency for the warrant

[\*] Monthly report to chief elected officials in accordance with Conn. Gen. Stat. § 4-68q, Notification of outstanding rearrest warrants and arrest warrants for probation violations: "Not later than the fifteenth day of the first month after the Office of Policy and Management obtains access to data on outstanding rearrest warrants and arrest warrants for violation of probation, and not later than the fifteenth day of each month thereafter, the undersecretary of the Criminal Justice Policy and Planning Division within said office shall notify the chief elected official of each municipality of the number of rearrest warrants and arrest warrants for violation of probation that have been issued for persons residing in that municipality and are still outstanding."

[\*\*] Active Failure to Appear Warrants and Active Violation of Probation Warrants with Law Enforcement Actions Noted means active PRAWN in accordance with Conn. Gen. Stat. § 54-2d, Notation in computer network of actions taken by law enforcement agency to execute certain warrants: "Not later than thirty days after the entry of the issuance of any rearrest warrant or arrest warrant for a violation of probation into the paperless rearrest warrant network, the law enforcement agency for the municipality in which the accused person resides shall, if such network is available and accessible to such agency, enter a notation in such network of the actions, if any, that have been taken by such agency to execute the warrant and apprehend the accused person."
