**Data:** The data in this report are from the Paperless Re-Arrest Warrant Network, known as PRAWN. The PRAWN system is maintained and operated by the Judicial Branch, Superior Court Operations Division, Office of the Chief Administrator.

**Definitions:** FTA means Failure to Appear on a criminal or motor vehicle proceeding. VOP means Violation of Probation.
