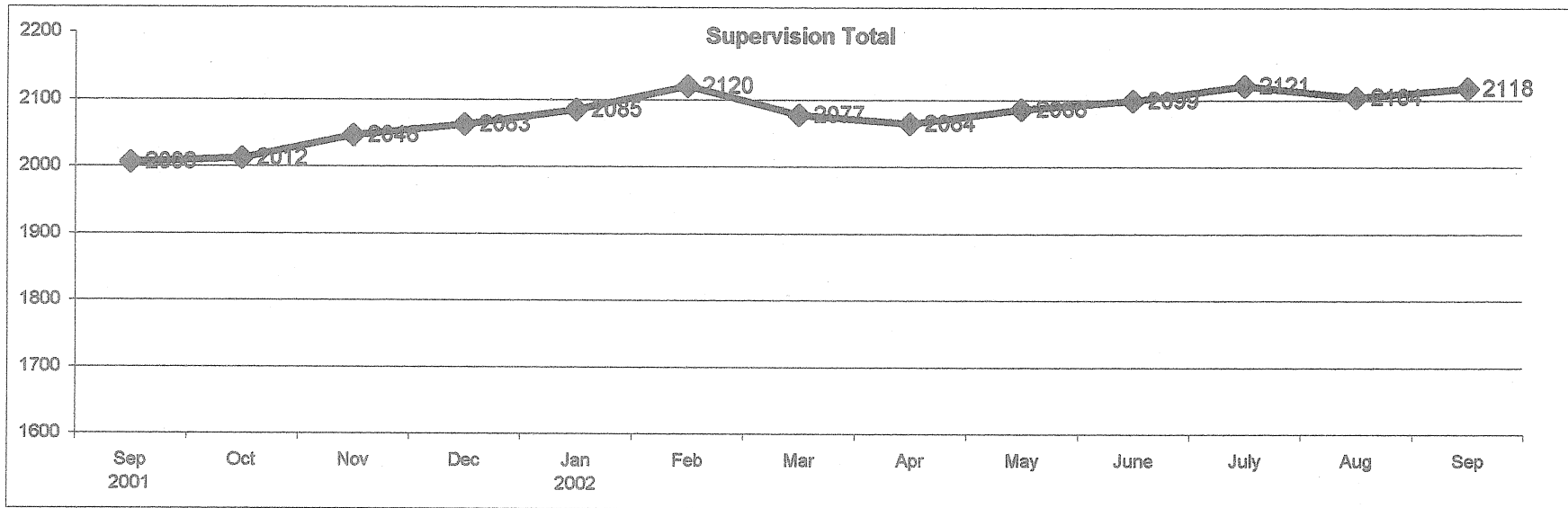


**Parole Granting Rate
October 2001 - September 2002**

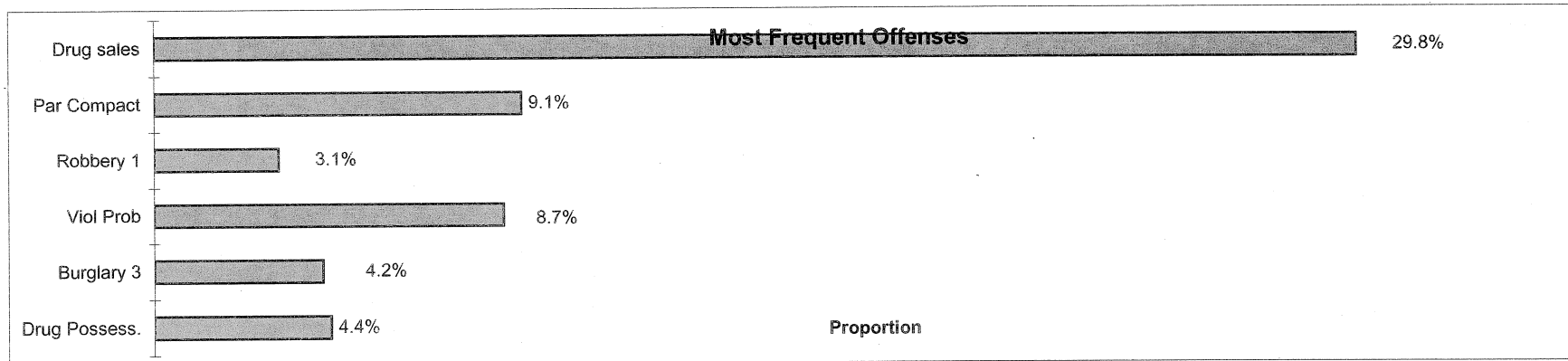
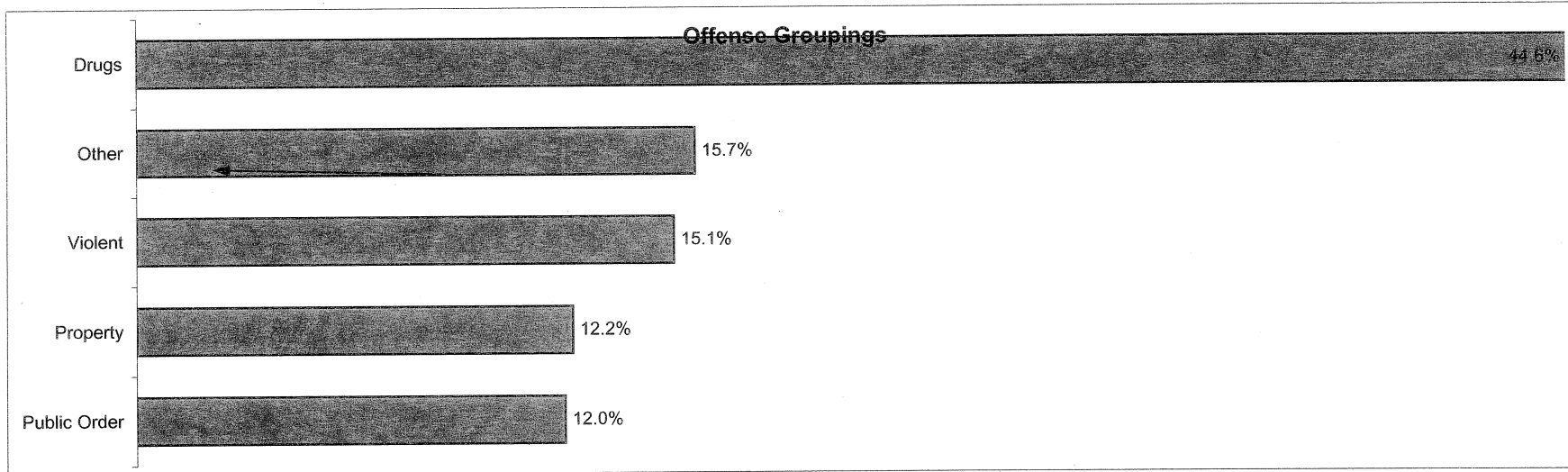
