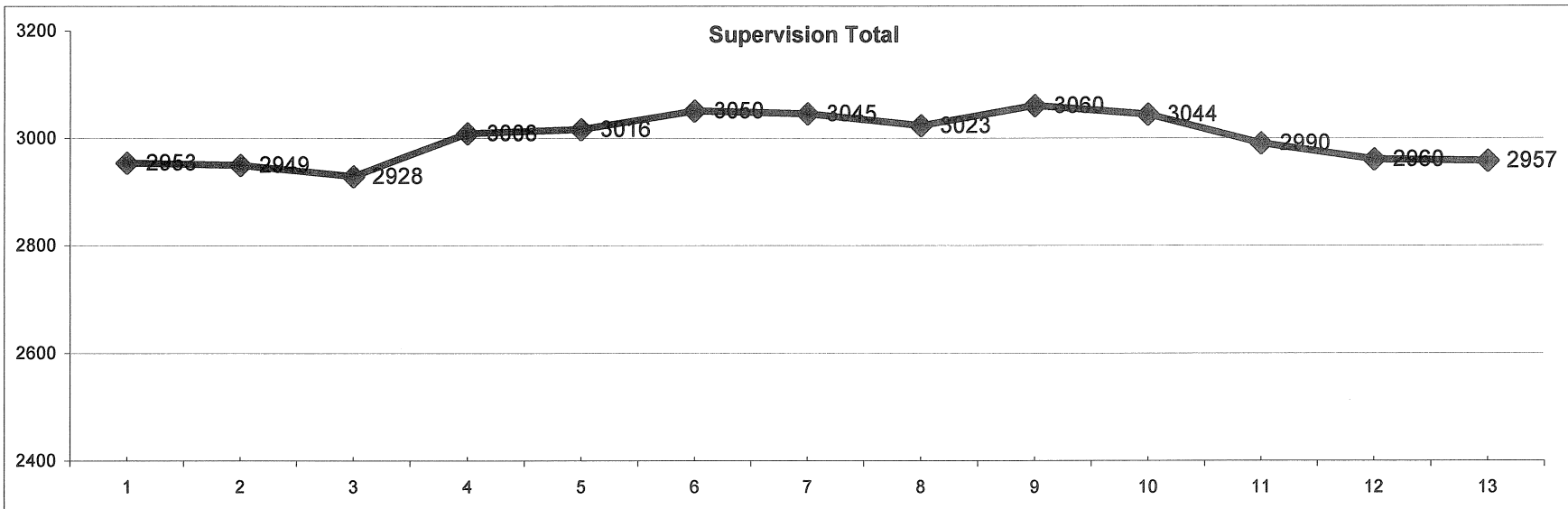


**Parole Granting Rate
March 2006 - February 2007**

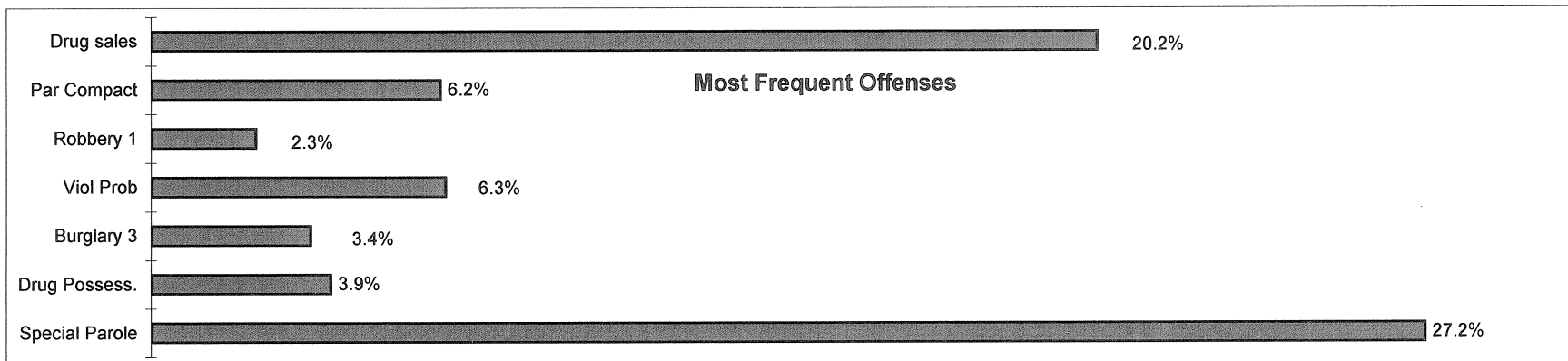
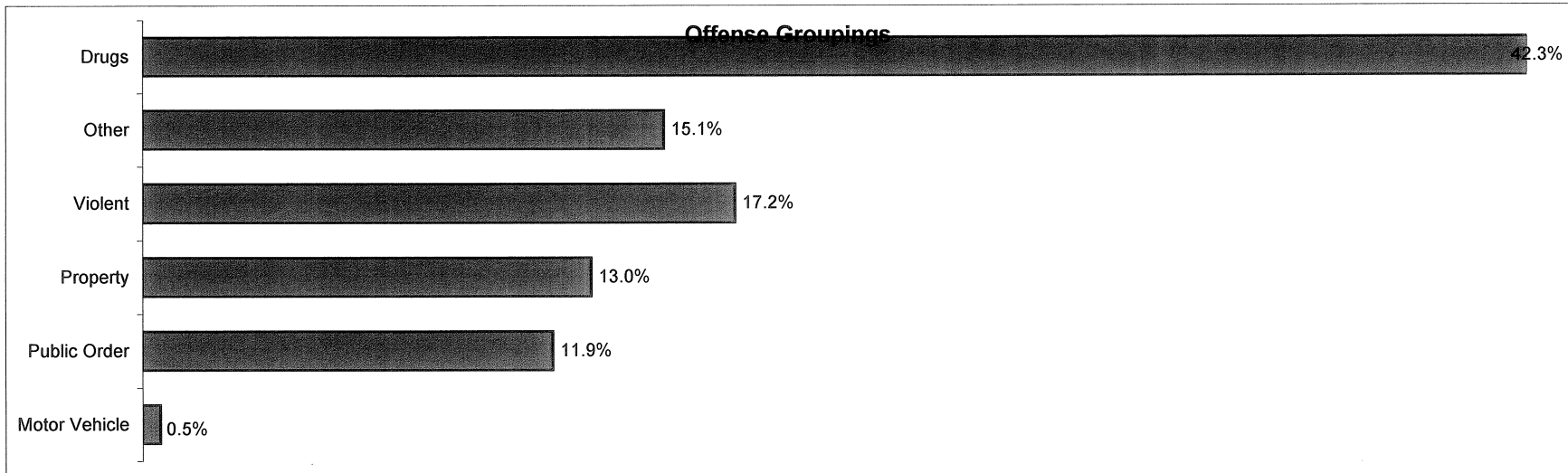
