Highlights

- On February 1, 2021, Connecticut's correction population—9,059 people—was 38 individuals fewer than on January 1. This slight net population reduction is atypical compared to the same period in prior years. (See Chart 4) Typically, there is a rise in the correction population around February 1 each year as an increasing number of criminal cases are processed in the beginning of the calendar year.
- OPM's 2021 Annual Forecast of the *Prison Population*, which was released this month, anticipates the correction population will remain relatively stable through 2021, a contrast to 2020, when the population decreased substantially.

- The Department of Correction's Community Release Unit (CRU) continues to show consistency in their approval rate. CRU's approval rate in January 2021 (45%) was similar to January of the prior year (46%). (See Table 3)
- On February 2021, the adult probation population reached 30,990 people, a 2% decline from last month, (See Chart 2) and an 18% decline from a year ago.

Prison Population Forecast

In the first week of February 2021, the final month under OPM's 2020 forecast, Connecticut's correctional facilities recorded an average daily count (ADC) of 9,044 people, which is 2,823 lower than the forecast. (See Table 1) In prior years, OPM's forecast has varied from recorded counts


within a range of ±5% by the end of each annual projection cycle. In stark contrast, the February 2021 ADC differed from the OPM projection by -24%. This divergence reflects, in large part, the impact of the COVID-19 pandemic, the effects of which exceed the statistical forecasting methods.

In 2020, the actual correction population began sharply diverging from OPM's forecast between March and April, the onset of the COVID-19 pandemic. (See Chart 1) As often discussed in the *Monthly* reports, the pandemic's

pervasive effects shifted operations and trends in the justice system in unforeseen ways, evidenced by the dramatic divergence of the prison population from the 2020 forecast. Finally, in an unusual finish to this cycle, Feburary 2021 represents the first instance where the correction population did not increase over the month of January. This final anomaly provides another powerful indicator of the lasting and unexpected effects of COVID-19 on the criminal justice system since its onset.

Chart 1 – Actual prison population against the OPM forecasts







Chart 2 - Criminal justice, monthly counts and flows

Chart 2a – Northern Correctional Institution Population Changes (1995-2021)



On February 8, Governor Lamont announced plans to close Northern Correctional Institution ("Northern"), the state's only level five, maximum security facility. Northern has a more restrictive correctional environment overall than the state's other facilities. Commissioner Quiros said, "The significant reduction in the population at Northern speaks to our staff's exceptional interpersonal skills, superior conflict resolution abilities, and overall understanding and application of criminal justice reform." The line chart above reflects Northern's population since opening in 1995. Consistent with Commissioner Quiros' quote, after 2003, when Northern's population reached its historical high count (507 people), the facility population shrank 89%, to 55 people, by 2021. Therefore, the announced closure of Northern reflects an evolution of DOC policy and practice over the years, leading to a population reduction as people requiring heightened security were safely housed in units within other facilities.






Chart 4 – Prison population, first-of-month 2018, 2019, 2020 and 2021




Chart 5 – Statewide Arrests 2020 and 2021

January 2020 through January 2021




Chart 7– Remands from community release January 2021





Chart 8 – DOC community supervision Jan 1, 2020 through Feb. 1, 2021
