OPM - Criminal Justice Policy & Planning Division Monthly Indicators Report

Highlights

- On March 1, 2021 9,050 people were incarcerated in Connecticut's prisons and jails. One year ago, on the precipice of a global pandemic, the count stood at 12,411 27% higher. Recent trends have been less dramatic. Since January 1, 2021, the correction population has been relatively flat, falling by only 47 people.
- OPM is in the process of incorporating new or revised metrics to describe front end criminal justice processes. Our intention is to gradually introduce changes, building on the model developed over the last dozen years. The first in a series of changes expected in 2021, OPM has updated its arrest metric. Following a hiatus since November 2020, statewide monthly arrest figures once again appear in Charts 2 and 5. A word of caution to readers: arrest data will not match prior reports. Starting this month, reported statewide arrests will include a new case type resulting in higher figures than previously reported. Despite the change, the overall trend remains the same. arrests thus far are lower this year vs last (see chart 5). For additional discussion, please see chart 2a on page 2.
- The number of people discharging from a DOC facility at the end of their sentence fell to 49 in February signaling both a reduced churn in the sentenced population and contrasted with the 242 previously sentenced people discharging from community settings, the concerted effort of the DOC and PCS to move as many sentenced offenders into the community as possible.

Prison Population Forecast

One month into the 2021 prison population forecast and OPM's estimate, as is often the case this early in the process, is holding form. A word of caution, at this point last year, OPM's forecast was within 89 of the actual count; a lot can change in the months to come. Uncertainty increases as

we get deeper into the forecast year, but current metrics depict a system currently in a state of balance. Admissions events reported in chart 2 on page 2 and table 2 on page 3 are nearly balanced by releases and discharges, resulting in very small month over month changes in the count of incarcerated people held in the DOC's prison and jails.

OPM will watch these metrics carefully in the coming months, with the expectation that admission events will gradually climb, stopping then ultimately reversing the current trend. The

expected change, contingent on external, societal factors independent and a priori to the operation of the criminal justice system, is difficult to time out. Once society at large returns to a degree of normalcy, operations within the criminal justice system will follow suit. OPM's input/output model will closely track changes, in near real time, reporting on them in this space in the months to come.

Chart 1 – Actual prison population against the OPM forecasts




Chart 2 - Criminal justice, monthly counts and flows




A routine review of the data elements published in the *Monthly Indicators Report* revealed that arrest data should include motor vehicle cases. OPM's arrest metric is based on cases added to court dockets, data collected by the Judicial Branch, transmitted and tabulated through CJIS. OPM has historically received data grouped into four docket types: criminal, motor vehicle, criminal infraction and motor vehicle infraction. Prior to the review, OPM reported only cases included in the criminal category.

Our conversations with subject matter experts at the Judicial Branch revealed that the addition of the motor vehicle category would enhance OPM's model of the criminal justice system, capturing, more accurately the volume of cases which could result in a bond, a pretrial admission to the DOC or potentially a sentence to term of incarceration.

Going forward OPM will report both categories as a single, statewide arrest figure. Historical analysis will be annotated to reduce confusion.

First week of the month, avg. daily count (ADC)




Chart 4 – Prison population, first-of-month




Chart 5 – Statewide Arrests 2020 and 2021




Chart 6 – Monthly DOC Admissions

February 2020 through February 2021




Chart 7– Remands from community release





Chart 8 – DOC community supervision Feb. 1, 2020 through Mar. 1, 2021
