  - Sierra Pretrial Center the provider has divided oversight between their criminal
    justice division and their behavioral health division and this has improved service
    provision; additional funds provided to increase 2<sup>nd</sup> shift staffing; CSSD and DMHAS
    conducting regular audits and client interviews; resources sometimes limit timely
    discharge.

  - ASIST Managed by CSSD, DMHAS, DOC. New London court provider ended contract; program rebid statewide; provider selected for Norwalk court, services (including bilingual Spanish) started recently.

  - New legislation permits APRNs who are employed by DOC to issue a written
     Emergency Certificate for a person with psychiatric disabilities who is a danger to
     himself or herself or others or gravely disabled and in need of immediate care and
     treatment. The Emergency Certificate authorizes and directs that a person person be
     taken to a general hospital for purposes of a medical examination and possible
     hospitalization. This would be used when such a person must be discharged from DOC
     custody.

#### 10. Other Items –

- Program funding options are limited due to the state budget. Keep the Promise Coalition was formed by advocates to generate support for "a comprehensive, community mental health system is created and sustained across the lifespan (children, adolescents, emerging adults, adults, older adults and families in Connecticut)."
- Criminogenic training for behavioral health staff discussed options for making training available to providers. CSSD's trainings may be an option.
- CPA SAMHSA grant for re-entry DOC, CPA, and Intercommunity are working collaboratively on the CPA Resettlement program. The program provides pre and post release peer-to-peer case management, treatment and support services to individuals diagnosed with a Substance Use Disorder and/or Co-occurring Mental Health who are returning to the Greater Hartford Community.
- Low charge/low bond defendants found not competent/restorable ordered to inpatient restoration – Monte Radler discussed options to provide other options to the court.
