

PSA and POS Annual Request for Waiver Report Calendar Year 2024

INTRODUCTION

A. Purpose

This document summarizes information pertaining to the Personal Service Agreement (PSA) and Purchase of Service (POS) requests for waivers from competitive solicitation by state agencies for Calendar Year 2024. As required by Connecticut General Statutes (C.G.S.) Section 4-216(b) and C.G.S. § 4-70b (e), this report includes the complete list of all waiver requests received during the previous calendar year and the justification for the approval or denial of such requests for executive branch agencies.

B. Background

A PSA and POS request for waiver is a request submitted via the CORE-CT requisition module to OPM identifying the qualifying waiver code, for the purpose of waiving the competitive procurement process. A request for a waiver from competitive solicitation is required by all state agencies pursuing a contractual agreement having a cost of more than fifty thousand dollars (\$50,000) and the state agency has determined that a non-competitive procurement is necessary.

A state agency can only execute a non-competitive PSA or POS contract after OPM has approved the waiver.

C. Scope and Methodology

OPM summarizes the information obtained from Core-CT and creates monthly waiver reports, published to the <u>OPM website</u>, and submits an annual report to the General Assembly and the State Contracting Standards Board. All requests for waiver from competitive solicitation must be submitted to OPM and meet at least one qualifying service or be denied such waiver request. These qualifying services are listed as justification codes in CORE-CT as:

- A The cost to the State of a competitive solicitation process would outweigh the benefits of such a process. (Note: This category should generally only be used for contracts with a value of less than \$100,000)
- B Supplier is mandated by federal law/grant (i.e., Medicaid), state statute, or public act.
- C Services provided are to prevent disruption in treatment outcomes and continuity of care for vulnerable populations or emergency services.
- D Evidence based, proprietary, special clinical/Medicare services, or unique/specialized skills.
- E Services and location by consent decrees, lawsuit disposition, litigation, or stipulated agreement.
- F Specific supplier location is funded by State bond funds or resources in real estate or physical plant to provide a level of service.
- G Hospitals and Universities under agreement provide research and training programs for emergency treatment services.
- H Zoning, citing & site licensing prohibit other suppliers due to funding or time.
