Brief Project Description/Summary: The Connecticut Department of Labor (CT DOL) has embarked on a business transformation initiative to modernize and improve its Unemployment Insurance (UI) Tax and Benefits systems for increased flexibility and adaptability required to provide improved service and sustained operational efficiency.
CT DOL is joining and will implement the system developed by the ReEmployUSA Consortium in this phase (Phase 3) of the project.
Summary of Progress Achieved to Date: <u>Phase 3 (System Implementation)</u>
UI Modernization has been delayed 13 months due to the agency's need to support federal changes to the UI program under CARES Act I and CARES Act II. The new implementation date is June 2022.
