Re: FISCAL YEAR 2024/2025 MUNICIPAL SPENDING CAP REPORT DUE BY JULY 1st OR 30 DAYS AFTER BUDGET ADOPTION

<u>Subsection (f) of Section 4-661</u> of the Connecticut General Statutes establishes a municipal expenditure cap. Each municipality shall annually certify to the Secretary of the Office of Policy and Management (OPM) whether such municipality has exceeded the cap set forth in this subsection and the amount by which the cap was exceeded.

Chief Financial Officers are to report spending cap data under the <u>Fiscal Health Monitoring System</u> (FHMS). The spending cap report may be submitted after completion of the municipality Fiscal Year 2024/2025 adopted budget submission. Both reports utilize the original adopted budget for July 1, 2024. Upon FHMS log in at <u>CT FHMS - Sign In</u>, you will first complete your budget reporting and then after acceptance, complete the spending cap report.

Primary contacts must log in and submit. If there Is a new primary assigned by a municipality, complete <u>fhms-new-primary-contact-form.pdf</u>.

The Submission of Municipal Spending Cap Budget Data job aid is attached.

FHMS data will be pre-populated with Fiscal Year 2023/2024 data and Fiscal Year 2024/2025 adopted budget from your budget submission.

Please note that while the language in subsection (f) provides some very general guidance regarding what expenditures are considered outside of "municipal spending", it does not provide definitions or specific guidance. OPM believes that it is the intent of the law to exclude business-type activities from municipal spending (i.e. water pollution control authority). You will need to interpret the language in the statute and make those determinations for your municipality. Please be consistent across fiscal years when doing so.

The amount of the grant payable to a municipality in any year in accordance with (d) of Sec. 4-661 shall be reduced if such municipality increases its general budget expenditures for such fiscal year above a cap equal to the amount of general budget expenditures authorized for the previous fiscal year by 2.5 per cent or more or the rate of inflation (6.27%), whichever is greater.
