Develop GISO Priority Topics

Working Groups

1. Ariel Imagery and Data Acquisition

- Will cover 2 flights, 2023 spring and the next to follow.
- Established rough timeline and each milestone.
- Develop a contract by late fall and winter, on track for start of the year.
- Determine the project lead still.
- Working on Draft for RFP, release by end of July.
- Building footprints, contours, and 3D imagery
- UCONN continue to host
- 2016 contract is the starting point
- Make sure the Towns are aware, and record of any municipalities that are doing buy-ups (extra features at an added cost) with the vendor.
- Investigate or review decrease accuracy by a small factor to make it more usable. Potential post processing to make more usable.

2. Geospatial Data Clearing House

- Start to learn from others
- Platforms spatial and non-spatial
- Offer download, what format
- Ability to preview data before downloaded
- If they have visualization Story maps and dashboards
- Branding
- How data is organized, easy to find/use
- How they provide access to metadata
- Accessibility for user ADA

3. Statewide Addressing and Geocoding

- Has not met officially yet
- Centerline is in good shape
- Challenges in licensing of address ranges, may have found a way around it. Process of plan to move forward
- Difficult challenge is the address points. Lots of missing values in E911 address layer. Brainstorm ways to improve layers.
- GIS office will take ownership of a version of E911 master address datasets, all potential uses of address.
- Improve by filling in as many of the gaps as possible.
- UI provided data, waiting on Eversource
- Continue to maintain data regularly, DOT will help to keep data up to date. Town reports roads to DOT, DOT provide to master address point data set.
- Hybrid GEO Locator end goal.
- Student enrollment, and department of social services two other end uses, dot use for LRS.
- MELISSA subscription potential organization of data

4. Broadband Mapping

- Initial clean of data, less points than addresses
- Missing newer developments
- Multi-dwelling unit not fully listed
- Should have an availability map, pending better data.
- Partnering with CCM to do a survey
- Constitutes input of where there is good broadband.
- Developing additional data verification
- Secondary survey follow up to CCM, refine data collection

5. CAMA working group

- Finishing up 2022 parcel data collection
- Most COGS have had great turn out this year, close to 100% compliance rate.
- Closer to getting everyone on same schema standards
- List of improvements for the 2023 CAMA Side
- Parcel side, still working on better standardize attributes

GIS Advisory Council Section 79 of Public Act 21-2 of the June 2021 Special Session

- New staff under GIO will work on aggregating parcel data for statewide use.
- Current status: wrapping up reaching out with COGS this week to get final data.
- CAMA 2nd year formalized collection, 100% compliance and delivery this year. Made a huge difference from previous years. This standardization is making it so statewide creation can be done.
- 2021 a lot of outreaches to towns which helped with compliance

6. Parcel Drafting Guidelines

- Met a few times, put together a detailed agenda, Parcel methods for obscure situations.
- List the different instances they could think of, put together methods on how to match each case.
- July 20 first draft on each instance. How to book on standardizing parcel development, and administrative boundaries they form.
- End of the year goal for the first draft of the document. Will be a living document that will continue to be edited and improved moving forward.

Last Updates/ Roundtable discussion:

- Hiring for GIS Analyst -setting up for interviews
- Looking to identify who is going to manage aerial imagery in coordination with the GIO office.
- Looking to hire a more senior position for more advance analysis and coordination
- Close to finishing the MOU with DOT for updating and improving administrative boundaries (municipal boundaries). Will replace DEEP layer, and update boundaries at the federal level as well.
- One of the council tasks is coming up with a 5-year plan for GIS in the state. What do we want to see in the 5 year plan for GIS in the State of Connecticut? Dive in for meeting.
- Potential efforts:
 - Wetlands and water bodies
 - Cemeteries
 - Acquisition sustainable program long term (imagery)
 - o State wide 3-D base map
 - o Social/Community Service informational layer: Heating/Cooling across the state
 - o Hydrography update help with regional mapping from LIDAR collected data.
 - Working with agencies who need additional help with getting the agencies up to date with GIS data
 - Town Hall Location to the state
 - o 211 inclusions
